<u>Ambulance Subsidy Update:</u> Supervisor Tekautz

Formal Agreement continues to be worked on, and is in draft form at this time. Agreement will need to be finalized before the first payment from the townships is due on June 30th 2020. Payment for 2020 will remain the same as last year, \$15.00 per capita to be paid to the TAAS. 1st payment will be due 06/30/2020, and 2nd payment to be due December 31, 2020. \$39,870 will be divided amongst the townships. Transfers have been decreased. Ambulance will reimburse \$1.66/mile from the per capita fund to the vehicle replacement fund per transfer. This will not apply to regular 911 calls. Tower is working on a business plan. There is to be \$0.00 transferred out of the vehicle replacement fund unless reviewed and approved by the ambulance commission.
