- Fire-written report-correction on Training Officer pay \$350, not \$300
- Road and Bridge-because of warm weather, roads tend to get sloppy. A lot of maintenance on equipment for December. Flooding rink was difficult with warm weather.
- McKinley Park-Dock at the Park has been reinforced by R&B. Seasonal payments continue to come in. February 1<sup>st</sup> 2021-will start taking payments for monthly reservations.
- Recreation-Rink flooded 9 times, Supervisor Dostert wanted to praise the good staff that he has. Staff is working hard and doing a good job. Attendance at the skating parties is down from last year. Hockey Days will be scheduled for February 14<sup>th</sup>, 2021 at 1:00pm. Asking for donations for bonfire material. No updates on donation of the remainder of hockey boards.
- Wastewater Board-Next meeting is tentatively scheduled for February 10<sup>th</sup> @ 11am. At the last meeting there was much discussion on I/I. Some capacity was noted available and connection approved by the Wastewater Board for the new RV Park. Army Corp of Engineers has approved a \$3.35 million dollar grant for filtration that was not approved last year through the State Bonding Bill. The anticipated cost of the project is \$4.5 million. \$250k grant coming from IRRR, and will apply for another \$250k dollar grant. Mesabi Trail discussed and work will begin in 2022. Per MPCA and the NOV on manholes along the trail, the board would like to begin repair and/or replacement ahead of the bike trail project. Projected cost for manhole project is \$400,000.

It is possible that the project will have to be reevaluated and prioritized depending on funding availability. The IRRR Grant Contract Agreement is for \$145,000, with the township having to match the IRRR for \$145,000.

I want to personally thank you, Chuck, and Greg for your trust and support in my leadership as the police chief for Breitung Township the last few years.





	Attachment B – Resolution Supporting Application
	The application must be accompanied by either a copy of a resolution, council
	minutes or some other official documentation that demonstrates that the local unit
	of government supports the proposed project and the consequent application. The
	resolution does not need to have a specific form or specific language, as long as it
	satisfies what was outlined in the previous sentence. A sample resolution has been
	included. The sample resolution is a combination type resolution example. It
	shows support of the grant application (as required above), and if the project is
	awarded, it includes language required to support accepting the grant award, names
	the fiscal agent, and states that the facility or trail will be maintained for no less
	than twenty years. This combination resolution helps eliminate the need for an
	additional resolution for this project in the future, if awarded a grant. If the
	applicant is awarded, all three items must be mentioned in the resolution in order
	to accept the grant.
	Attachment C – 20 Year Operations and Routine Maintenance Plan
	Outline how this project will be maintained after the grant is completed. How often
	will maintenance occur? What funding sources will be used to ensure that this
	project is available for public use for the next 20 years?

	Letters of support are an important factor for reviewers when selecting projects.

	of support from all other sources as well. There is no limit on how many letters
	may be submitted, and diversity is favorable.
