- Road and Bridge-because of warm weather, roads tend to get sloppy. A lot of
  preventative maintenance on equipment for January. Maintenance Supervisor Tom
  Gorsma asked if it is possible to hire Teddy Kruger for brushing on the Junction Rd due
  to Elderbrush at a cost of \$150/hour and a \$400 reporting fee. Kruger stated it was
  approximately a \$2800 cost. Supervisor Dostert mentioned that the Town Board should
  look at alternating brushing each year with review of Echo Point, Puncher, Mallard
  Drive, and McKinley Park Acres.

Jayne doing pizza on Tuesday's and Wednesday is also a big hit.

Wastewater Board-Filtration Project update from SEH is now estimated to be an additional 1M in cost for an estimated total of 5.4M. Funding amounts are up to 3.6M. (3.35M from Army Corp of Engineers, 250K from IRRR) SEH will go to Senator Thomas Bakk for 1.75M in bonding should funds become available and will go back to the Army Corp of Engineers for more funding, as the Corp will fund up to 75% of the project. The Wastewater Board will ensure funding is available before project starts. The City of Tower could be looking for bids on their Water Main Project. WWB looking at new rate structure to implement in January of 2022. Minutes of the WWB will be posted to the City of Tower's website, and it was asked if minutes could be sent to the Breitung Clerk so that minutes can be posted to the Breitung Township website as well. The Mesabi Trail Project will be using JPJ Engineering for the Project, and repairs and or replacement to the manholes along the trail will be done ahead of this project at a projected cost of \$400k per MIPCA and NOV's on manholes. Work will begin in 2022.

Job posted on Police Board by Chief Nylund when Lieutenant Sanderson left, has not received any applications, there are many vacancies and applications/resumes due by the end of February 2021.

Inflow and Infiltration Grant Update-CDBG & IRRR

The Breitung Township Inflow and Infiltration Reduction project has been awarded \$245K (145K from IRRR and \$100k from CDBG) with the township having to match the IRRR for \$145,000. This project is to free up more capacity at the ponds and there are 4 areas of concern that have been noted. Maintenance Supervisor Gorsma met with JPJ Engineering, and the top (2) priorities are the Sewer Main repairs, and Manhole Repairs. JPJ Engineering will come back with better cost estimates and bids will go out this spring.

Plow Truck Replacement

No bids as of yet, but should have one in a few days. Delivery of new truck if approved could be as soon as this coming July. There is a time slot for a company in Wisconsin for a truck to be outfitted with box and sander this coming September that is being held.
