

I'm writing to ask for your assistance to help Rural Development reach even more people who might need help. We want to continue to assist households in need and get our funding spent. Please share our program information to anyone who might find our program useful.

A couple of benefits to our 504 Repair program:

- Homeowner's must live in an eligible rural area of Minnesota and both own and occupy the dwelling.
- The repair loan is for very-low income homeowners with a fixed 1% interest rate and 20-year term. Maximum loan is \$40,000.
- Grant funds are limited to a lifetime award of up to \$10,000 for very-low income elderly applicants age 62 or older. Grant eligible repairs must be health and safety related or be utilized for accessibility improvements for a disabled household member.
- Work is completed by a licensed contractor.
- Typical repairs include but are not limited to: roof, well, septic or sewer line replacements, radon mitigation and accessibility improvements.

I've attached our fact sheet for both the 504 Repair and the 502 Purchase programs along with the PSA Announcement. Feel free to distribute these items to homeowners who you run across in your day-to day work. We want your referrals and can partner with other agencies to assist in financing!

## USDA Accepting Applications to Help Low-Income Individuals and Families Buy or Repair Homes

USDA Rural Development is accepting applications for very low- and low-income individuals and families seeking to purchase or repair a home in a rural area.

The Direct Home Loan program offers financing to qualified very-low and low-income applicants that are unable to qualify for traditional financing. No down payment is required, and the interest rate could be as low as one percent with a subsidy. Applicants must meet income and credit guidelines and demonstrate repayment ability. The program is available in rural communities of generally 35,000 people or less.

The maximum loan amount is \$40,000 at a one percent interest rate, repayable for a 20-year term and can be used to improve or modernize homes and do essential repairs. Grants of up to \$10,000 are available to homeowners 62 and older and must be used to remove health or safety hazards, such as fixing a leaking roof, installing indoor plumbing, or replacing a furnace.

## Rural Home Loans (Direct Program)

# What does this program do?

Also known as the Section 502 Direct Loan Program, this program helps low- and very-low-income applicants buy decent, safe, and sanitary housing in eligible rural areas by providing payment assistance to increase their applicant's repayment ability. Payment assistance is a type of subsidy that reduces the mortgage payment for a short time. The amount of assistance is determined by the adjusted family income.

#### Who can apply for this program?

A number of factors are considered when determining eligibility for Single Family Direct Home Loans. At a minimum, applicants must have an adjusted income that is at or below the applicable low-income limit for the area in which they wish to buy a house (an income limit map is available at this link: <a href="https://go.usa.gov/xzcfb">https://go.usa.gov/xzcfb</a>). They must also demonstrate a willingness and ability to repay debt.

#### Applicants must:

- Be without decent, safe, and sanitary housing
- Be unable to obtain a loan from other resources on terms and conditions that can reasonably be expected to be met
- Agree to occupy the property as their principal residence
- Have the legal capacity to incur a loan obligation
- Meet citizenship or eligible noncitizen requirements
- Not be suspended or debarred from participation in federal programs

## Properties financed with direct loan funds must:

- · Be modest in size for the area
- Not have market value in excess of the applicable area loan limit
- Not be designed for incomeproducing activities

Borrowers are required to repay all or a portion of the payment subsidy received over the life of the loan when the title to the property transfers, or the borrower is no longer living in the dwelling.

Applicants must meet income eligibility for a direct loan. Regardless of repayment ability, applicants can never borrow more than the area loan limit (plus certain other costs eligible to be financed) in the county in which the property is located (information is available at this link: https://go.usa.gov/xzcGB - PDF)

## What is the interest rate and payback period?

- The interest rate is fixed, and based on current market rates at loan approval or closing, whichever is lower.
- When modified by payment assistance, the monthly mortgage payment can be reduced to a low as an effective 1 percent interest rate.
- The payback period is 33 years (38 years for very-low-income applicants who can't afford a 33-year loan term).

## How much down payment is required?

Down payments are not typically required, but applicants with assets higher than the asset limit can be required to use a portion of those assets.

# Who can apply for this program?

To qualify, you must:

- Be the homeowner and occupy the house
- Be unable to obtain affordable credit elsewhere
- Have a family income within the very-low-income limit
- For grants, be age 62 or older and not be able to repay a repair loan

#### What is an eligible area?

#### How can funds be used?

- Loans can be used to repair, improve, or modernize homes, or to remove health and safety hazards.
- Grants must be used to remove health and safety hazards.

#### How much money can I get?

- Maximum loan is \$40,000.
- Maximum grant is \$10,000.
- Loans and grants can be combined for up to \$50,000 in assistance.

## What are the terms of the loan or grant?

- Loans are repaid over 20 years.
- · Loan interest rate is fixed at 1 percent.
- Full title service is required for loans greater than \$25,000.
- · Grants have a lifetime limit of \$10,000.
- Grants must be repaid if the property is sold in less than three years.

 If applicants can repay part - but not all - of the costs, they may be offered a loan and grant combination.

#### Is there a deadline to apply?

Applications are available year-round as long as funding is available, and are processed in the order they are received.





## Minnesota iron and the green economy

One hundred and eighty people attended a free public one-day virtual event on March 16 that focused on how the green steel movement will affect Minnesota iron ore. Minnesota Iron & The Green Economy event was hosted by Mineland Vision Partnership (MVP) and Society for Mining, Metallurgy and Exploration (SME).



Topics of discussion included greenhouse gas (GHG) emissions, climate change, clean energy and sustainability in the American steel industry. Ten organizations presented information, including American Iron and Steel Institute, Cleveland-Cliffs, Jasper Engineering, Minnesota DNR, Minnesota PCA, Minnesota Power, Natural Resources Research Institute, St. Louis County, US Steel, and US Department of Energy.




Some of the top points presented were:


- Steel will be in demand. Proposals for greening the United State economy involve major investments in clean energy, infrastructure and upgrading the electric grid all of which require steel. Steel is an enabler of renewable energy technologies.
- America's steel industry is the cleanest and most energy efficient of all the
  major steel producing countries. Shifts in the steel industry have resulted in
  greener production, such as pelletized iron ore in place of sintered iron, natural
  gas instead of coal as an energy source, and the increased use of electric arc
  furnaces (EAFs). Between 60-80 million tons of steel scrap is recycled annually
  into new steel products.
- Northeastern Minnesota energy and steel sectors are making great progress.
   Minnesota Power is the first in the state to achieve 50% of energy generated from renewable sources and has a goal to deliver 100% carbon-free energy by 2050.
   Minnesota Power's 50% (and increasing) renewable energy mix helps the region's mining companies provide the cleanest metals, resulting in the cleanest steel.


## Redhead Mountain Bike Park garners environmental award



The Redhead Mountain Bike Park in Chisholm won an award from Environmental Initiative for work done to transform an area that housed ten idled iron mines into an outdoor recreation facility. The Environmental Initiative Rural Vitality Award will be presented in a virtual ceremony on May 18.

The 25-mile trail opened in 2021 and traverses amidst 1,225 acres of mining impacted land with rich red earth surfaces, steep and rugged rock ledges, lush green forestry, and open mine pits full of clear blue water. Iron Range Resources & Rehabilitation supported the project with Mineland Reclamation

The Redhead land once yielded iron ore that was transferred to America's steel mills. Mining ceased on the parcels several decades ago, and the property now draws mountain bikers, hikers, e-bikers, kayakers, canoers and other outdoor recreation enthusiasts.



"The Redhead trail represents how mining-

impacted land can be responsibly reclaimed for the economic betterment of northeastern Minnesota," said Commissioner Mark Phillips, Iron Range Resources & Rehabilitation. "Redhead is adding to the quality of life for local residents, attracting tourism spending, and is a business recruiting tool for the health care, manufacturing and other large industries."

# Businesses, communities and outdoor recreation in northeastern Minnesota receive over \$15.6 million in economic development funding

Approximately \$12.2 million in loans and over \$3.3 million in grants were approved at today's Iron Range Resources & Rehabilitation Board meeting. Total combined project investment is approximately \$57.4 million. The projects are expected to increase the regional tax base, create permanent and construction jobs, provide essential services, and expand outdoor recreation. The loans and grants combined are anticipated to impact 866 jobs. The infrastructure grants are projected to create 202 construction jobs.

#### Business Development: \$12,740,592

Agency Investment: \$12,240,592 Loans & \$500,000 Infrastructure Grant | Total Project Investment \$30,490,685 | Leverage: 1.4:1

Chisholm-Hibbing Airport Authority (CHAA), Hibbing: \$10,000,000 Loan &
 \$500,000 Infrastructure Grant to construct a 60,000-square-foot addition

to the existing operations at the airport campus of Detroit Diesel Remanufacturing, LLC (DDR). The added space will be used to support the remanufacturing of parts to help support the DDR parent company, Daimler Truck North America's electric vehicle (EV) business. DDR will remanufacture EV batteries, qualify, repair and upgrade microchips, remanufacture power inverters and manufacture other HV products. Total project investment is approximately \$17.5 million and includes the creation of up to 18 new jobs. DDR will lease the new space from CHAA through a long-term lease agreement.

- 1987: DMR was founded in a garage in Hibbing by local resident Hugh Vidovic. The company produced new and remanufactured electronics components for the truck, bus, heavy-duty equipment and light rail industries.
- 2007: Detroit Diesel Remanufacturing, LLC acquired DMR.
- 2013: Detroit Diesel Remanufacturing, LLC signed a lease with CHAA for a 30,000-square-foot spec building. Two months later, the building was expanded by another 30,000 square feet. The project was supported by Iron Range Resources & Rehabilitation.

"The electrification of medium- and heavy-duty commercial vehicles is just beginning in earnest, but the future support to keep them running stretches far into the supply chain and manufacturing operations. The highly specialized electrical engineering and technical expertise of our staff will be key to the electric future for our company, and we're very proud to expand our presence in Hibbing to support that future." - Wally Buegler, Detroit Diesel Remanufacturing Plant Manager.

"Chisholm/Hibbing Airport Authority is a major economic development hub for northeastern Minnesota, and the expansion of Detroit Diesel Remanufacturing's footprint and operations demonstrates what we can offer new and expanding businesses. - ASV Holdings, Inc., Grand Rapids: \$1,000,000 to expand the existing facility and construct a 60,000-square-foot high-bay warehouse that accommodates assembly layout modifications and additional equipment. The expansion will meet a significant ramp-up in production of compact track loaders and accommodate new product launches. The total project investment is approximately \$9.4 million and includes the creation of hundreds of jobs over the next five years. ASV was recently acquired by Yanmar Group, and the expanded facility allows for a strong increase of compact equipment production in Grand Rapids. ASV has been operating in northeastern Minnesota for nearly 40 years.
  - 1983: ASV was founded in a small garage in Marcel, Minnesota. It grew and became an industry leader in compact equipment production, sales and parts distribution.
  - 1995: ASV moved to a new, larger facility in Grand Rapids to accommodate its growth and success.
  - 2019: ASV was acquired by Yanmar Group, and ASV's independent dealer network throughout North America, Australia and New Zealand joined Yanmar's global construction equipment operations.

"The merger of ASV and Yanmar provides significant opportunities in the North American market for both brands. Substantial growth is expected in the Yanmar and ASV lines of compact equipment, which necessitates the investment in increased operational capacity in North America. We are proud of our Minnesota roots and are very pleased to expand our facility and capabilities in Grand Rapids." - ASV President Tate Johnson.

- Reynolds Manufacturing, Inc. & Reynolds Enterprises, LLC, Grand Rapids: \$1,010,000 to purchase the assets and real estate of Northland Machine.
   The new ownership will retain existing staff and capture demand for precision machined parts.

Development Infrastructure Grants: \$1,538,894

Agency Investment \$1,538,894 | Total Project Investment \$19,502,567 | Leverage: 11.7:1

- City of Grand Rapids: \$350,000 to construct infrastructure for the expansion of ASV's production facility that includes the addition of a 60,000-square-foot high-bay warehouse.\*
- City of LaPrairie: \$312,000 to construct infrastructure for a new recreational vehicle park and campground located on the Prairie and Mississippi Rivers that includes 49 new campsites. The new infrastructure will also enable future residential housing development.
- City of Silver Bay: \$700,000 to construct infrastructure for the development of a planned housing and resort development that includes new residential housing, town home and tiny house rentals, commercial storage and an event and wellness center.

- Iron Range Tourism Bureau (IRTB): \$100,000 to fund the Northern St. Louis
  County Trails Task Force Small Trail Projects grant program. The program is
  administered by IRTB and provides grants to cover costs related to trails
  and trail facility/amenity projects in the region.
- Itasca County: \$80,000 to construct a non-motorized bituminous trail located within the city of S. Lake to establish a safe route for pedestrians and provide a connection to businesses and community services. The project is the second phase of a pedestrian/ATV trail developed in 2016 and is a collaboration with the Leech Lake Band of Ojibwe.
- Northern ATV Joint Powers Board: \$50,000 to develop a master plan for ATV trail connectivity and expansion in St. Louis, Koochiching and Lake counties.

Iron Range Resources & Rehabilitation funds its loans and grants through taxes paid by Minnesota's mining industry. The projects approved at today's board meeting support the agency's FY22 spending plan which focuses on leveraging capital, improving the quality of life and retaining and creating well-paying jobs. The agency works to support businesses, communities and workforce development projects that make northeastern Minnesota a desirable place to live, work and play.

Other funding partners for the approved projects include private businesses, cities and their economic development authorities, counties, joint powers boards, Blandin Foundation, Community Development Block Grant Program, Ely Independent School District 696, Environmental Protection Agency's State & Tribal Assistance Grant, Federal Recreational Trails Program, Minnesota Department of Employment & Economic Development (DEED), DEED Minnesota Investment Fund, Minnesota Department of Transportation, Minnesota Public Facilities Authority, Point Source Implementation Grant, and United States Economic Development Authority.

Dear Tim Tomsich:

This letter serves as notice that \$418,000.00 of State Park Road Account Funding is hereby authorized to Saint Louis County for reconstruction of Stuntz Bay Road from Jasper Street through the pit crossing on the top of the hill and address erosion issues near the bottom of the hill on Stuntz Bay Road which provides access to Lake Vermilion - Stuntz Bay Public Water Access.

State Park Road Account funds are to be used for access road construction/maintenance and necessary supporting infrastructure to state recreational units. This funding cannot be used for improvements to recreational facilities (e.g., parking lots, trails, boat ramps, etc.). County State Aid Highways must be approved by the County State Aid Screening Board.

The following criteria must be met before the authorized projects are let and contracts are awarded:

- The unit of government (county, township, city) initiating this project must review the project with the DNR Area Hydrologist and Wildlife Manager to determine if the project has any adverse effect on protected waters or lands currently enrolled in the Reinvest in Minnesota (RIM) program.
- 2. A plan must be developed, signed by a registered engineer, and submitted to the MnDOT District State Aid Engineer through the County Engineer.
- 3. The Department of Transportation, Office of State Aid, will review the plan, and if acceptable, will notify the county engineer and the local unit of government to proceed with letting, force account or negotiated agreement.
  - A. The County shall administer the contract, force account or negotiated agreement.
  - B. For projects managed by the County, the County Engineer will supervise the construction and budget as the work progresses.
  - C. On all projects, the District State Aid Engineer will monitor the progress of the project according to the specifications and proposals.
- 4. Payment requests as submitted by the County Engineer and based on estimates or force account agreements, shall be administered in accordance with State Aid rules and payments will be made to the County Treasurer.
- 5. Overruns are the responsibility of the local unit of government unless approved by the Department of Natural Resources and the State Aid Engineer.

- 6. Right-of-way costs (payments to land owners) are a reimbursable cost.
- 7. Engineering costs are the responsibility of the local unit of government.
- 8. The minimum standards for any improvement must be designed as shown on the attached sheet.

## STATE OF MINNESOTA 2022 VOTING EQUIPMENT GRANT AGREEMENT (VEGA-3)

This grant agreement (hereinafter "Agreement") is made between the State of Minnesota, (hereinafter, "State") acting through its Secretary of State, 180\_State Office Building, 100 Rev. Dr. Martin Luther King Jr. Boulevard, Saint Paul, MN 55155-1299 ("State") and St. Louis County - Breithung Township, PO Box 56, Soudan, MN 55782 ("Grantee").

### Recitals

- 1 Under Minnesota laws 2021, First Special Session, Chapter 12, Article 1, section 6, Minnesota Laws 2019, 1st Special Session, Chapter 10, Article 1, section 6, and Minnesota Laws 2017, First Special Session, Chapter 4, Article 3, § 17, coded as Minnesota Statutes, § 206.95, the Grantee is empowered to apply for the funds requested in this Agreement, and submitted a grant application under subdivision 3 of that section on or before December 17, 2021, and the State is empowered to enter into this grant.
- 2 Grantee represents that it is duly qualified and agrees to perform all services described in this Agreement to the satisfaction of the State and in accordance with all state laws authorizing this grant. Pursuant to Minn.Stat.§16B.98, Subd.1, the Grantee agrees to minimize administrative costs as a condition of this grant.
- 3. The State is in need of assurance that Minnesota elections are conducted on modern voting equipment. Grantee is in need of funds to purchase optical scan counters, assistive voting devices, or electronic roster systems.
- 4. Grantee represents that it has insufficient resources to purchase these counters, devices or systems without the grant amount provided pursuant to this agreement.

## Agreement

## 1 Effectiveness of Agreement

- 1.1 Effective date: February 14, 2022, or the date all required signatures, including those required by Minnesota Statutes, § 16B.98, Subd. 5, have been affixed to the agreement by Grantee and State, whichever is later. Per Minnesota Statu ₹8, S ubmitte and the State a proved a work plan and budget. grante Per, Minnesota Stati ill be : od. 7, ng ade to the Grar ayme e until this grant agreement is fully approved and ecuted, a s been otifi s Authorized Representative that they are by 1 in compliance with e terms
- 1.2 Expiration date: Section 1, 2011, or who all funds applied or and provide to Grantee by State have been expended, whichever occurs first.
- 1.3 Survival of Terms. The following clauses survive the fulfillment of this grant agreement: 4. Conditions; 8. Liability; 9. State Audits; 10. Government Data Practices; 12. Property Insurance; 13. Governing Law, Jurisdiction, and Venue; and 14. Data Disclosure.

## 2 Grantee's Duties

2.1 Activities. The Grantee, who is not a state employee, will comply with required grants management policies and procedures set forth through Minn.Stat.§16B.97,Subd. 4 (a) (1) and will use all funds provided as a result of this Agreement for the purchase of optical scan counters, or assistive voting devices in the manner described in this Agreement and as set forth in the Grant Application previously submitted by Grantee and attached hereto. As Chief County Election Official, the County Auditor or Election Director is responsible for fulfilling all requirements of Grantee under this agreement. Grantee will use the funds awarded only for the procurement of the voting equipment set forth in the Grant Application except as set forth in paragraph 2.4 of this Agreement.

Grantee is hereby awarded \$1,949.50 for purchase of Optical Scan Precinct Counters/Systems that can process four column ballots or Assistive Voting Devices. Grantee must match this grant with \$1,949.50 of local funds.

Grantee will expend all funds granted by this Agreement as well as the required match pursuant to Minnesota . Statutes, § 206.95, no later than May 31, 2022, or will return all unspent grant funds to the State by June 10, 2022, for potential redistribution.

- 2.2 Reporting Requirements. Grantee shall report to the State as specified in this Agreement.
  - (1) Progress Reporting. Grantee shall submit, by June 10, 2022, a financial reporting form to the State utilizing the format identified by the State, stating the amount spent in calendar year 2022 for the

- purchase of each kind of voting system, how many were purchased, and how much of the grant award remains to be spent, if any.
- (2) Final Reporting. Grantee will submit a final report, no later than June 10, 2022, or 30 days after the grant amount has been fully expended, whichever comes first, including all items listed in 2.2 (1) above as well as cancelled checks, invoices and paid bills, agreement and sub award documents, and records sufficient to detail history of procurements. These records must prove the total expenditure of the Grant Amount and the required total match pursuant to Minnesota Statutes, § 206.95, subdivision 4, or if less than all grant funds were expended, the total of the expended grant funds and the proportionate match required by Minnesota Statutes, § 206.95, subdivision 4.
- (3) Other Requirements. Subgrantee must maintain financial records for each grant sufficient to satisfy audit standards and must transmit those records to the secretary of state upon request of the secretary of state.
- (4) Evaluation. State shall have the authority, during the course of this grant period, to conduct an evaluation of the performance of Grantee.
- (5) Requirement Changes. State may modify or change all reporting forms at their discretion during the grant period.
- (6) Special Requirements. The State reserves the right to append to the Agreement terms, at any time before all grant funds have been expended, special administrative requirements deemed necessary to assure Grantee's successful implementation of the program. The State will notify the Grantee in writing of any special administrative requirements.

## 2.3 Accounting Requirements - Fiscal Control and Accounting Procedures.

Grantee's fiscal control and accounting procedures must be sufficient to:

- (a) Permit preparation of reports required by this Agreement,
- (b) Permit the tracing of funds to a level of expenditures adequate to determine that funds have not been used in violation of this agreement, and
- (c) Support accounting a sords arough surce do a ments, so chast cancelle checks, invoices and paid bills, agreement and so award a currents, and ecord surficient detail history procurements.

Grantee may spend funds from the purchase of tical scale are not ballot coursers that are capable of processing four column ballots on assistive voting devices, and funds granted for the purchase of assistive voting devices on optical scan precinct ballot counters, if they are capable of processing four column ballots, or in either case for combinations thereof, if the change is reported in the next financial report due after the purchase.

### 3 Time

Grantee must comply with all the time requirements described in this Agreement. In the performance of matters funded pursuant to this Agreement, time is of the essence.

## 4 Consideration and Payment

- 4.1 Consideration. The State will make an award to Grantee under this Agreement as follows:
  - (1) Grant Award. The Subgrantee will be awarded the amount listed for the Grantee in paragraph 2.1 of this Agreement.
  - (2) Total Obligation. The total obligation of the State to Grantee under this grant agreement will not exceed the amount stated in paragraph 2.1 of this Agreement.
- 4.2 Fiscal Requirements. Grantee shall report to the State as provided by paragraph 2.2 of this Agreement.
  - (1) Financial Guidelines. Grantee's eligible expenditures under this grant agreement must be specifically incurred by Grantee. Grantee will report on all expenditures pertaining to this grant agreement as provided in paragraph 2.2.
  - (2) Records. Grantee shall retain all financial records for a minimum of six (6) years after the date of submission of the final financial report, or until completion of an audit which has commenced before the expiration of this six-year period, or until any audit findings and/or recommendations from prior audit(s) have been resolved between the Grantce and State, whichever is later, and comply with all other Retention and access requirements for records provided in the jurisdiction's retention schedules.

4.3 Payment Invoices. State will pay the grant amount to an account of Grantee within 30 days after the effective date of this Agreement.

## 4.4 Conditions.

- (1) Payments under this Agreement will be made from funds appropriated by Minnesota Laws 2021, 1st Special Session, Chapter 12, Article 1, section 6, Minnesota Laws, 2019, 1st Special Session, Chapter 10, Article 1, section 6, and Minnesota Law 2017, 1st Special Session, Chapter 4, Article 3, section 17. Grantee is responsible for compliance with all requirements imposed on these funds and accepts full financial responsibility for any requirements imposed by the Grantee's failure to comply with statutory or grant agreement requirements.
- (2) Grant funds must be used only to increase the funds that would, in the absence of this grant, be made available for procurement of the equipment set forth in paragraph 2.1 and operating expenses as defined by law.
- (3) Grantee assures that equipment to be acquired with these grant funds is required because Grantee has need of the equipment, and has insufficient funds for that purchase. Grantee also assures that equipment purchased with grant funds will be used for all elections as required by law. Grantee agrees that it will only purchase optical scan precinct counters/systems that can process 4 column ballots, or assistive voting devices, certified under M.S. 206.57.
- (4) Grantee, for five full years following the purchase of equipment with grant funds, may dispose of that equipment only after first offering the equipment to Minnesota jurisdictions using the same type of equipment. During that five-year period, Grantee may only sell the equipment at or below a price equal to the amount of the funds initially expended by Grantee for the equipment purchase, excluding the grant made pursuant to this expen or any ally received from the Help America te Act, ıds om the le of t must be retur uipme d to the jurisdiction's Help America Vote A t (HAV. ac ided on must, ret ned a for the purposes of HAVA.

## 5 Satisfaction

All duties required and agreements or assurances provided by Grantee in this Agreement must be performed to the State's satisfaction, as determined at the sole discretion of the State's Authorized Representative and in accordance with all applicable federal, state, and local laws, ordinances, rules, and regulations.

## 6 Authorized Representative

The State's Authorized Representative is David Maeda, Director of Elections, 180 State Office Building, 100 Rev. Dr. Martin Luther King Jr. Boulevard, Saint Paul, MN 55155-1299, 651-556-0612, or his successor, and has the responsibility to monitor the Grantee's performance and compliance with this Agreement.

Grant payment will be made to: St. Louis County - Breithung Township Federal ID Number: 41-6005007

Grantee must be registered as a vendor in the SWIFT system, or must provide a W-9 form with this executed agreement, in order for State to register Grantee in the SWIFT system.

If Grantee's Authorized Representative changes at any time before the funds provided for in this Agreement are fully expended, Grantee must immediately notify the State.

## 7 Assignment Amendments, Waiver, and Grant Contract Complete

### 7.1 Assignment

Grantee shall neither assign nor transfer any rights or obligations under this grant contract without the prior

written consent of the State, approved by the same parties who executed and approved this grant contract, or their successors in office.

### 7.2 Amendments

Any amendments to this grant contract must be in writing and will not be effective until it has been executed and approved by the same parties who executed and approved the original grant contract, or their successors in office. 7.3 Waiver

If the State fails to enforce any provision of this grant contract, that failure does not waive the provision or the State's right to enforce it.

## 7.4 Grant Contract Complete

This grant contract contains all negotiations and agreements between the State and the Grantee. No other understanding regarding this grant contract, whether written or oral, may be used to bind either party.

## 8 Liability

Grantee must indemnify, save, and hold the State, its agents, and employees harmless from any claims or causes of action, including attorney's fees incurred by the State, arising from the expenditures of the funds provided by this Agreement by Grantee or Grantee's agents or employees.

### 9 State Audits

Under Minnesota Statutes, § 16C.05, subd. 5, and 16B.98, subd. 8, Grantee's books, records, documents, and accounting procedures and practices relevant to this Agreement are subject to examination by the State and/or the State Auditor or Legislative Auditor, as appropriate, for a minimum of six years from the end of this grant agreement, receipt and approval of all final reports, or the required period of time to satisfy all state and program retention requirements, whichever is later.

## 10 Government Data Practices

Grantee and State must comply with the Minnesota Government Data Practices Act, Minnesota Statutes, Ch. 13, as it applies to all dat rreemer der this I data created, collected. by t er this Agreem received, stored, used nt. ## 11 Workers' Compensation

Grantee certifies that it is in compliance with Minnesota Statutes, § 176.181, subd. 2, pertaining to workers' compensation insurance coverage. Grantee's employees and agents will not be considered State employees. Any claims that may arise under the Minnesota Workers' Compensation Act on behalf of these employees and any claims made by any third party as a consequence of any act or omission on the part of these employees are in no way the State's obligation or responsibility.

## 12 Property and Casualty Insurance

Grantee is required to maintain a property and casualty insurance policy covering "All Risk" (or equivalent) of direct physical loss or damage, including, but not limited to, the perils of transit (if applicable), theft, and flood for the counters, devices or systems acquired using funds granted under the Agreement. The insurance limit shall be equal to the replacement cost of the election equipment. Any deductible shall be the sole responsibility of Grantee. Self-Insurance is sufficient to meet this requirement.

### 13 Governing Law, Jurisdiction, and Venue

Minnesota law, without regard to its choice-of-law provisions, governs this Agreement. Venue for all legal proceedings out of this Agreement, or its breach, must be in the appropriate state or federal court with competent jurisdiction in Ramsey County, Minnesota.

## 14 Data Disclosure

Under Minnesota Statutes, § 270.66, and other applicable law, Grantee consents to disclosure of its social security number, federal employer tax identification number, and/or Minnesota tax identification number, already provided to the State, to federal and state tax agencies and state personnel involved in the payment of state obligations. These identification numbers may be used in the enforcement of federal and state tax laws which could result in action requiring the Subgrantee to file state tax returns and pay delinquent state tax liabilities, if

any, or pay other state liabilities.

## 15 Termination.

The State may immediately terminate this grant contract with or without cause, upon 30 days' written notice to the Grantee.

## 16 Grantee Procurement

Grantee certifies that it will use the procurement processes applicable in Grantee's jurisdiction in purchasing equipment with funds subject to this Agreement.

While the CDBG Advisory Committee has completed its process, those recommendations must be approved by the County Board. That process will take place after HUD's notification to St. Louis County of its CDBG award. Reduced funding from HUD may mean reduced funding to your project.

Because of this delay, we would like to take a moment and remind you of the next steps.

- **Before requesting bids**, please contact St. Louis County staff. Failure to do so may require rebidding of the project or make it ineligible for CDBG reimbursement.
  - Federal Labor Standards 4010, Section 3, and the correct Federal Wage Decision must be incorporated into BOTH the Bid Spec and Contract.
- Once you have contacted St. Louis County staff, you may solicit bids and award contracts.
  - Proposed work may begin prior to 5/1/2022, however, those expenses <u>are not</u> reimbursable by CDBG.
- Communities and agencies proceed at their own risk if undertaking their project prior to County Board approval and issuance of a 2022 CDBG contract with St. Louis County.
