#### **Old Business:**

Infrastructure Projects-Currently waiting for Mesabi Bituminous update. No updates on Poplar Street, Mesabi Bit currently doing trail work. 2023 Infrastructure on hold. Supervisor Tuchel met with USDA, no new information. USDA only funds water & sewer (maybe some storm/sanitary but minimal). JPJ is aware of project qualifying for USDA. Would need a new Median Income done, and would need resident participation if going this route. USDA offers more loan dollars than grant dollars. Chairman Tomsich ready to go back to IRRR for 2023 Infrastructure Project. Currently the project sits @ 626k, look to see where costs can be reduced (there are 2 cost estimates, possibly reduce 1 of the 2). PFA a possibility, but may be needed for Mesabi Trail project as the pipe under the bridge needs to be changed, and may need to take a draw. Will discuss more at the August meeting.

• <u>Flagship Recreation and Landscape-</u>Chairman Tomsich working with Stacey and will make a plan to meet with the company and park employees. Will take measurements during meeting. Stephanie Ukkola happy to volunteer time if and when needed.

<u>Blight-</u>Jasper St cleaned up some but still dealing with excessive items in the yard. Chief Reing working with residence on Poplar St and building rapport with homeowner

<u>Care Crossings Update-</u>Vermilion Park Inn held an informal Q&A on July 9<sup>th</sup>, 2023 from Noon-2pm, Supervisor Tuchel was in attendance. Owner of VPI stated that she never applied for a CUP through St. Louis County. All Supervisors getting questions from residents in regards to the sober living home. Correspondence from St. Louis County is that nothing is happening because a CUP has not been applied for. Commissioner Nelson asking for the publics feedback. Just a reminder that ambulance can not go to the sober living until police have arrived.





#### **BEAD Five-Year Action Plan**

The Broadband Equity, Access and Deployment (BEAD) program provides funding for broadband infrastructure and the preparation of a plan by each eligible entity for how to achieve internet for all. As Minnesota's eligible entity, the Office of Broadband Development submitted the state's BEAD Five-Year Action Plan (Appendix 7.1 OBD Meetings 2014 to 2022 and Appendix 7.2 NTIA Local Coordination Documentation Tracker) to NTIA in July. Minnesota will receive a total of \$651,839,368. State amounts were calculated from the number of unserved locations (locations without reliable broadband service of at least 25Mbps download and 3Mbps upload) within each state based on new maps that the Federal Communications Commission (FCC) developed as well as the number of such locations in areas deemed to be high cost.



"This type of machine was new to our facility. Our staff was not familiar with how it operated and how it could be used in our manufacturing processes," said Sandy Bryant, Revolv plant manager. "The workforce training enabled us to

upskill our existing employees at no cost to our company. It was a great training opportunity and increased the expertise and skills of our employees."

Revolv recently received a new large order for consoles that are often seen on Lund brand boats. The staff used their newly acquired skills on the Rotary Thermoforming machine to fulfill the order. The boat console order is one example of how Revolv's new

machine and newly trained staff will expand its manufacturing operations and services to customers.



F&D Meats in Virginia renovates building with grants geared to help small business owners

Owner Joseph Walls utilized a Business Energy Retrofit (BER) and Downtown Building Rehabilitation (DBR) grant to make energy efficiency and code compliance upgrades to the meat shop that he and his wife purchased in 2020. F&D Meats has been operating in Virginia for more than 40 years providing fresh cut meats and groceries. The Walls are carrying on the tradition and investing in the 50-year-old building to elevate the customer experience.

The interior walls of the retail areas were upgraded. Custom charred-wood shiplap was installed in the grocery and wellness sections, and a combination of brick, paint and corrugated metal was added to the main meat shop area.





The grants also assisted with new flooring, energy efficient lighting, doors and windows. Equipment upgrades included coolers, freezers and a new meat smoker to replace the existing smoker that gave out.

"Our goal from the very beginning has been to continue providing the same quality products that F&D has provided to its loyal customer base for the past four decades," said Walls. "The grants

helped us give the store a major facelift that not only improved the aesthetics of the building but also added operational and energy efficiencies to help us achieve our goal."

F&D has long been popular for its in-house smoked bacon, beef jerky, beef sticks and porketta. F&D continues to offer those items, traditional recipes and a variety of fish, beef, pork, poultry, seasonings, fresh produce, dairy products, party platters and household supplies. The Walls have added new options such as fresh coffee, honey, maple syrup, organic produce, health and beauty products, handmade artisan gifts and specialty holiday items.



# City of Virginia breaks ground on new entrance to Olcott Park




The city of Virginia broke ground on a new historically-inspired entrance to Olcott Park. Iron Range Resources & Rehabilitation supported the project with a \$20,000 Culture & Tourism grant. Total project investment is estimated at \$109,000.

Construction began last week, and completion is anticipated in late August. In addition to creating a grand entrance to the park, the project will widen the northern entrance (9th Street) to allow for

two-way traffic and increased accessibility.

The park is home to the Olcott Park Electric Fountain and Rock Garden which the city refurbished in 2018. The fountain is officially listed in the National Register of Historic Places, placing it in the company of sites across the nation that have been declared worthy of preservation in order to protect America's historic and archaeological resources. The park is also the site of youth baseball, music in the park, picnic pavilions, playgrounds, a disc golf course, a paved walking



trail, a community greenhouse and the local historical society. Three of the region's major festivals take place each summer in the park: Land of the Loon, Sand Lake Shuffle and Brewfest.



Other project partners include US Steel, Olcott Park Brewfest, Virginia Community Foundation and the city of Virginia.

# Coleraine restores historic landmark church, enhances heritage tourism

The city of Coleraine repaired and upgraded the exterior and deck of the historic Episcopal Church of the Good Shepherd, often referred to as "The Log Church." The scope of work included grading and staining the deck, chinking and caulking the logs to prevent water traps and adding vertical log stair spindles. The church is a highly visible landmark in Coleraine that was placed on the National Register of Historic Places



in 1980. The facility is part of Coleraine's historic walking tour and is used for community events, concerts and weddings. Iron Range Resources & Rehabilitation supported the project with a \$16,000 Downtown Streetscapes grant. Total project investment was \$32,000.



The Log Church was built in 1908 and was the first church to be completed in Coleraine. The last church service was held there in 1982. It was deeded to the city in 1987, which requires the city to maintain the building and uphold the basic architecture and appearance so that it remains on the Register of Historic Places.


Coleraine is nestled on the north shore of Trout Lake in north central Minnesota's Itasca County. It was established as a Canisteo Company mining town in 1909 and named after Thomas F. Cole who was once the president of Oliver Mining Company. The church's construction was supervised by John C. Greenway, a church parish member and Oliver Mining Company superintendent.

The logs used in the construction of the church were taken from one of the area's few remaining patches of virgin timber. The church interior and cathedral ceiling are built entirely of wood. The altar rail and lectern are made of



birch logs, and a large stained-glass window is a memorial to Greenway's young nephew who drowned in a hunting accident.

The building maintenance and preservation is funded solely from proceeds of rental fees. Private donations, Blandin Foundation and Minnesota Historical Society have also helped fund past restoration projects.



Iron mining ceased decades ago in Coleraine. The rural community now offers abundant fishing, hunting, golf, outdoor recreation and winter skiing at Mt. Itasca to residents and tourists.

Beginning last year, the Downtown Streetscapes grant merged with the Culture & Tourism grant and has a fiscal year budget of \$600,000. <u>Email Danae</u> <u>Beaudette</u> or call her at 218-735-3022 for Culture & Tourism grant information.

# Businesses, communities, outdoor recreation and education in northeastern Minnesota receive over \$7.4 million in economic development funding

At today's Iron Range Resources & Rehabilitation Board meeting, approximately \$3.1 million in loans, \$3 million in infrastructure grants, \$700,000 in trails grants and \$630,000 in higher education grants were approved to advance projects in northeastern Minnesota. Agency total investment for all projects combined is approximately \$7.4 million. Total project investment is approximately \$87 million. The projects are expected to increase the regional tax base, retain and create new jobs, provide essential services, increase the housing inventory, expand outdoor recreation and enhance higher education. The loans are anticipated to impact 178 jobs. The infrastructure projects are projected to impact 22 jobs and create 169 construction jobs.

Direct Loan: \$2,500,000

Agency Investment \$2,500,000 | Total Investment \$55,427,035

**L&M Supply, Inc., Grand Rapids: \$2,500,000** to construct a 200,000-square-foot greenfield, state-of-the-art distribution center. The new distribution center will replace one that is operating in nearby LaPrairie but is not large enough to accommodate the company's current operations and anticipated future growth. The project involves the addition of advanced computer-aided forklifts, conveyor systems for moving product within the distribution center, a sortation system to increase efficiency and a new warehouse management system to increase accuracy, visibility and systematic knowledge of inventory at all states of processing. Thirty-five to 50 new jobs are projected, and 83 jobs will be retained.

The first L&M Supply store opened in Grand Rapids in 1959. It was a 30' x 60' wooden building. Today, L&M has one corporate office/distribution center and 12 retail store locations in northern Minnesota, Wisconsin and Michigan. It is led by the third generation of family owners who reside in the Grand Rapids area. L&M stores offer outdoor power equipment sales and service, and products related to fishing, marine, hunting, firearms, workwear, fashion clothing, footwear, automotive, farm, pet and home improvement.

"The Grand Rapids area has been the home base for L&M for the past 64 years and we are proud to continue our company growth in our hometown. Our mission has always been to serve our customers' needs, and this new distribution center will ensure that we can fulfill that mission for years to come." – Shawn Matteson, L&M Fleet Supply Co-Owner.

- City of Buhl: \$151,362 to construct infrastructure, site work and roadways
  for a new housing development. The Damian II Addition will provide 10
  single-family home lots. The city recently sold the last available lot in the
  Stubler Addition creating a need for the development of new residential
  lots.
- City of Chisholm: \$500,000 to construct infrastructure, site work and roadways for a new 11,000-square-foot building that will house a new child care facility, clinic and county services. The child care center will be licensed for 90 full-time children ages six weeks to 12 years.
- City of Silver Bay: \$500,000 to excavate and construct infrastructure and site work for a new housing development near Bayview Park. The Boathouse Bay project includes 53 housing units and a resort to be built out over the next five years.

#### Community Infrastructure Grants: \$1,865,364

Agency Investment \$1,865,364 | Total Investment \$19,344,892

- Bois Forte Band of Chippewa: \$386,500 to construct infrastructure and site
  work for a new 13,800-square-foot public works facility. The Vermilion
  Public Works Facility will provide space for equipment and vehicles used in
  the public works and housing departments. There will be office space, a
  conference room and a food shelf area that provides services to band
  members residing in Vermilion and to surrounding communities.
- City of Grand Marais: \$250,000 to construct infrastructure and new road surfaces for Fifth Avenue West, a major connector between Highway 61 and the Gunflint Trail. The avenue serves public service centers related to

- health care, water, fire suppression, recycling and the court system. Residential housing and private businesses are also served by the avenue.
- City of Hibbing: \$500,000 to construct infrastructure related to 1.6 miles of water main, add a water valve and replace a hydrant. The new water main will replace antiquated and malfunctioning cast iron pipes which were installed from 1923 to 1925. The project will provide Hibbing Public Utilities the opportunity to replace 33 lead service lines.
- City of Keewatin: \$350,578 to improve the O'Brien Reservoir recreation area with demolition of an existing dilapidated restroom facility, construction of a 24' x 30' four-stall handicap accessible restroom facility, septic system installation and parking lot improvements. The project will also replace the curbs, sidewalks and overhead street lights on North First Street.
- City of Orr: \$243,411 to replace Orr Regional Airport's outdated fueling system. The existing fueling system and supporting software does not meet current standards and will soon be obsolete. The airport has seven hangars with a waiting list. It is utilized by Minnesota Department of Natural Resources as a base for fire suppression and wildlife surveillance.
- City of Virginia: \$134,875 to upgrade the elevator and men's handicap
  accessible restroom at Arrowhead Economic Opportunity Agency's (AEOA)
  headquarters in Virginia. AEOA provides essential services in several area
  counties related to energy assistance, seniors, nutrition, early childhood
  and adult education, homelessness, housing, weatherization, employment
  and training, food access, transportation, youth services and business
  assistance.

#### Regional Trails Grants: \$700,000

Agency Investment \$700,000 | Total Investment \$3,982,430

- Itasca Driftskippers Snowmobile Club: \$50,000 to purchase a new 2023 Piston Bully snowmobile trail groomer that will improve uptime, reduce maintenance costs, improve safety and improve trail conditions in the Grand Rapids area.
- Lutsen Trailbreakers Snowmobile Club: \$100,000 to replace a highly used snowmobile trail bridge that was destroyed in a flood during the spring of 2022. The bridge crosses the Poplar River and is on the Lutsen Access Trail, which provides access from remote area trails to downtown Lutsen where riders can access food, fuel, emergency services and lodging. The trail and bridge are also used by bikers and hikers.

- North Superior Ski and Run Club (NSSRC): \$50,000 to purchase a new snow cat groomer to groom the Pincushion Nordic ski trails in Grand Marais for classic and skate techniques.
- St. Louis and Lake Counties Regional Railroad Authority: \$500,000 to complete construction of a five-mile gap segment of Mesabi Trail from McKinley to Biwabik, connecting the Virginia area to the Giants Ridge and Embarrass area. A portion of the new segment includes a floating trail over the wetland.

Iron Range Higher Education Account: \$630,000

Agency Investment \$630,000

- Minnesota North College: \$400,000 to support the Iron Range Engineering BELL program which collaborates with private industry and allows students to earn a Bachelor of Science degree in engineering from Minnesota State University Mankato. Since 2009, the program has graduated 290 students and has received worldwide recognition for its innovative engineering education approach.
- Minnesota North College: \$230,000: to support the operations of the five foundations that serve the college's students and campuses of Hibbing, Itasca, Mesabi Range, Rainy River and Vermilion. The grant will help purchase donor and scholarship management software, staff professional development.

Iron Range Resources & Rehabilitation is funded through taxes paid by Minnesota's mining industry. The projects approved at today's board meeting support the agency's FY24 spending plan which helps the agency funds projects in business, community and workforce development that retain and create jobs, address customer priorities, leverage investment and improve the quality of life for all residents.

# New production winery in Coleraine uses combination of grants and loans to launch successful opening

Smoke on the Water, a production wine and cider facility located on Trout Lake in Coleraine, opened for business in June. Owner Tia Marie utilized grants and loans from Iron Range Resources & Rehabilitation and her own private investment to transform a vacant firehall into a winery and restaurant with a wood-fire kitchen and specialty bar.



Tia Marie purchased the building from the city of
Coleraine which is located five miles east of Grand Rapids. It had been vacant for several
years and was in disrepair. Iron Range Resources & Rehabilitation provided a \$50,470
Commercial Redevelopment grant to the city to help with internal and external
demolition of roofing, siding, walls, windows and other components.



"Smoke on the Water is a tremendous asset to our economy and community," said Coleraine Mayor Tom Nielsen. "We were fortunate that the building was available for a local business entrepreneur to open such a unique place for residents and tourists to enjoy."

Tia Marie was awarded a \$20,000 Business Energy Retrofit (BER) grant to help make the building more energy efficient with new siding,

electrical, plumbing and 12-foot waterfront-facing windows. She also secured a \$380,121 business loan to launch her new enterprise. Total project investment was \$1.5 million.

"Several of the grants and the loans offered by our agency are designed to help small business owners expand and improve their buildings and sites, their internal operations and their workforce," said Iron Range Resources & Rehabilitation Commissioner Ida Rukavina. "Our Business and Community Development staff is available to answer questions and guide business and cities through potential projects, whether that be a production winery like Smoke on the Water, a storefront on main street or a large manufacturing business in an industrial zone."



Smoke on the Water will produce its own ciders and wines in tanks onsite and using grapes grown in Minnesota and California. Beverage manufacturing has been one of the fastest growing industries in northeastern Minnesota over the last 10 years. Brewery, cidery, winery and distillery employment rebounded quickly from the pandemic and surpassed pre-pandemic levels in under a year. The robust recovery indicates continued consumer demand and growth in an industry that connects to tourism.



"Smoke on the Water is the only restaurant on Trout Lake, making it a popular choice for boaters and anglers," said Tia Marie. "We can host groups up to 125 people, and a small party room can accommodate 15. An outdoor deck overlooks the lake and provides access to Cotton Beach. Our future plans include an outdoor stage for live music where boaters may dock and listen."

Tia Marie is a retired school teacher of 28 years. In addition to Smoke on the Water, she owns UnWined Up North which is located in Grand Rapids and opened in 2019. UnWined Up North won Star Tribune's Best Wine Bar in Minnesota Award for 2021 and 2022. Smoke on the Water has five full-time and ten part-time employees and is open daily serving pizzas, sandwiches, homemade bread and soups, wine, ciders, beer and cocktails. 

# Goodland Township renovates community playground



Goodland Township expanded and renovated its existing 25-year-old playground to better serve the community and make it ADA compliant. Outdated and aging equipment was replaced with features that appeal to children of varying age levels and abilities. Iron Range Resources & Rehabilitation supported the project with a \$30,000 Culture & Tourism grant. Total project investment was \$110,018.

The playground is a popular gathering place for Goodland families and residents who often use it for family picnics and birthday parties. It is located adjacent to a ballfield and community center that serves as a rental venue for private functions such as weddings and funerals. The facility is also utilized as a senior center, community gathering space and election polling site.

"The upgrades created a wonderful park for families and children of all ages," said Sarah Detjen, Goodland Township resident and community volunteer. "It supports the overall quality of life in Goodland and strengthens the township's offerings to our residents."

Goodland Township is located in southeast Itasca County and has twice the geographic area than most townships at 12 miles long and six miles wide.



The enhanced playground and adjacent community center is a focal point of the township that draws from Goodland and the surrounding areas of Warba, Sago and Floodwood Lake.



Project partners included Goodland Township, Blandin Foundation, Nashwauk Area Community Foundation, Itasca County Transportation Economic Development, Essentia Health, Minnesota Power and community volunteers.

## **Veterans Park in Cook improves accessibility**

A 130-by-50-foot paved parking lot was completed at Veterans Riverfront Park in Cook to make the park and veterans flag dedication area handicap accessible. Curbs and much needed drainage were added to the parking area to eliminate flooding that was occurring during heavy rainfalls. Iron Range Resources & Rehabilitation supported the project with a \$24,999 Culture & Tourism grant. Total project investment was \$130,839.

The park features a memorial honoring past, present and future veterans. There are picnic tables, grills, a flag pole, steel swings, benches, landscaping and a fence separating



the park from the parking lot. An estimated 500 veterans reside within a 45-mile radius of the park. Veterans of Foreign Wars (VFW) Post 1757 is located in Cook, and American Legion Post 480 is in nearby Orr.

Veterans Riverfront Park began development in 2021 on an unoccupied parcel of land on the banks of the Little Fork River at the end of Cook's main street. The project was led by local nonprofit Friends of the Parks with unanimous support from the Cook City Council.



"The park provides an outdoor community space for residents, tourists and area veterans, and the new parking lot provides greater accessibility for all visitors," said Tammy Palmer, Friends of the Parks member. "It has benefited local businesses by drawing traffic into our community. People can share meals, gather with friends, exercise and play outdoors."

Other project partners for the parking lot included St. Louis County, local businesses, construction unions, organizations and private individuals who donated time and money.

The performance paid tribute to the historic past of the Iron Range including glacial movement, Native American life, discovery of iron ore deposits, immigration, mining, industrialization and a myriad of other significant events.



Nearly 850 tickets were sold. A combined total of approximately 230 vocalists, musicians and conductors performed on stage including members of The Choralaires, Range of Voices, The Sectionals, Voices of Reason, Virginia High School Choir, Rock Ridge High School Orchestra, Mesabi Symphony Orchestra and Virginia High School alumni.

"The concert provided a way for the community to celebrate and bid farewell to a premier performance venue which has been used by artists and performing groups for well over a century," said Sheila Wilcox, Rock Ridge Orchestra director. "The support from the community was fantastic, and the evening's music, artistry and historical importance were truly a reflection of what is outstanding about the Iron Range."


# Focus on HPV (Human Papillomavirus)



Human papillomavirus (HPV) is a very common virus that is spread through intimate skin-to-skin contact. Most of the time, the body clears the virus. However, people who do not naturally clear the infection may have health problems that develop, including pre-cancers and cancers of the throat and mouth, cervix, vulva, vagina, penis, or anus as well as genital warts.

On-time vaccination of 11 and 12 year-olds prior to HPV exposure is the best way to prevent these cancers and genital warts. Vaccination can be started at age 9 years and those who did not start or finish the vaccine series can be vaccinated through age 26 years.

Getting Ready for Back to school is a great time to review current immunizations. When a child reaches pre-teen and teen years, there are some extra vaccines recommended.

### **Meningococcal Disease**

cord, and it can also cause blood

#### COVID-19

CDC now recommends that the updated (bivalent) Moderna and Pfizer COVID-19 vaccines be used for all doses given to people age 6 months and older.

The original (monovalent) Pfizer and Moderna COVID-19 vaccines will no longer be used.

Hoodoo Point Campground's campers were victims of a string of thefts over the holiday. Campers who left their vehicles unlocked woke up to find numerous items stolen. We are working with the Duluth Police Department on this case. This is an active investigation so I am unable comment further. I can confirm some items were recovered and returned to the victims. We are still working on identifying the suspect(s). Once again, a reminder to be aware of spam calls and fraud callers.

As you can tell by the numbers, our department increased speed enforcement this month. Speeding in Soudan and Tower has been a major complaint by our residents. July is also a Minnesota statewide enforcement month, as other departments also increase their speed awareness and enforcement. I also completed two statefunded TZD shifts in our area in this month. Excessive speed can kill, please be safe.



# AGREEMENT BETWEEN ST. LOUIS COUNTY AND BREITUNG TOWNSHIP CONCERNING DISTRIBUTION PLAN FOR ALLOCATING FUNDS FROM VOTER ACCOUNT

This agreement is entered into by and between St. Louis County (the "County") and Breitung Township (the "City or Town").

WHEREAS, Minn. Stat. § 5.305 (the "Statute") was enacted in 2023.

WHEREAS, under the Statute, the County receives an annual distribution of funds from the State of Minnesota's Voting Operations, Technology, and Election Resources Account (also known as the VOTER Account).

WHEREAS, under the Statute, the funds must be allocated among the County and local units of government within the County.

WHEREAS, under the Statute, if the County and local units of government within the County do not agree on a distribution plan for allocating funds, the County must allocate funds according to a formula set forth in subdivision 4(a) of the Statute.

WHEREAS, the County and the City or Town have reached agreement on a distribution plan for allocating funds that would otherwise be allocated to the City or Town according to the formula set forth in subdivision 4(a) of the Statute.

NOW, THEREFORE, the County and the City or Town agree as follows:

- 1. The County shall retain all funds that would otherwise be allocated to the City or Town according to the formula set forth in subdivision 4(a) of the Statute.
- 2. This agreement applies to the distribution of funds received by the County in 2023 and all subsequent years, unless the agreement is terminated pursuant to the next section.
- 3. A party may terminate this agreement by providing to the other party written notice of termination at least sixty days before July 20 of any year, with the termination taking effect on July 20 of that year. Termination will not affect any pre-termination allocation of funds, and under no circumstances will the City or Town have any right to recover any funds retained by the County before the termination takes effect.
- 4. The parties represent that they have read and understand this agreement, that they have had the opportunity to review and discuss this agreement with their respective counsel, and that they intend to be bound by the terms of this agreement.
- 5. This agreement is the final expression of the parties and the complete and exclusive statement of the agreed-upon terms. It shall supersede all prior negotiations, understandings, and agreements concerning the matters addressed herein. There are no representations, warranties, or stipulations, oral or written, not contained herein.

In 2023, legislation was passed to establish a Voting Operations, Technology, and Election Resources (Voter Account) that provides a dedicated funding stream for elections administration. The funds are distributed to the county on an annual basis and the county is responsible for disbursing the funds to cities / townships.

The \$1.25 million fund was allocated to counties according to the following formula: 20% of the fund was allocated equally to all 87 counties and 80% of the fund was allocated based on the proportion of registered voters. The total amount allocated to St. Louis County is \$39,362.83.

Based on the default allocation formula, the allocation amount for the Township of Breitung is \$30.96. The county is required to work with its local units of government to determine how the funds will be allocated within the county.

Since the county currently administers absentee balloting for the township and does not bill related costs back to the township, we are asking that you allow St. Louis County to retain the Voting Operations, Technology, & Election Resources (VOTER) Account Funds allocated to your township.

If your township agrees to allow the county to retain the allocation, please complete the attached agreement and return it to our office. If not, please email our office at <a href="mailto:elections@stlouiscountymn.gov">elections@stlouiscountymn.gov</a> to inform us that you would like to receive your allocation.

# Voting Operations, Technology, & Election Resources (VOTER) Account

#### **Section A. VOTER Account Overview**

**Summary:** On July 20, the Office of the Secretary of State completed the electronic transfer of \$1.25 million in electronic payments to counties for the Voting Operations, Technology, & Election Resources (VOTER) Account. Allocations by county are included in Section B.

#### What is the VOTER Account?

The VOTER Account is a dedicated stream of state funding for county and municipal election administration. Funds were approved in 2023 Session Laws, Chapter 62 (Article 1, Section 43 and Article 4, Section 6). \$1.25 million will be allocated to counties according to the formula listed below. These funds will be allocated by July 20 each year, starting this year, until the law is amended by the legislature.

#### How were the total amounts determined for each county?

- 20 percent is allocated equally to all 87 counties
- 80 percent is allocated based on proportion of registered voters (using May 1, 2022 numbers)

#### What do counties need to do once the funds are received?

Upon receipt of funds, each county must segregate the funds in a county election funding account. The money in the account remains in the account until it is spent for any of the authorized purposes.

## Do counties need work with cities/townships to determine how the funds will be allocated within the county?

Yes. The county and the local units of government located within the county may devise their own agreement/formula for distributing the funds.

If the county and a local unit of government do not agree on a distribution plan, the county must allocate the funds to that unit of local government as follows:

- 50 percent is retained by the county;
- 25 percent is allocated to each local unit of government responsible for administering absentee voting or mail voting in proportion to that unit of government's share of the county's registered voters on May 1 for the most recent statewide general election; and
- 25 percent is allocated to cities and townships in proportion to each city and township's share of registered voters in the county on May 1 for the most recent statewide general election

If an agreement is reached between the county and *some* cities/townships, but not *all*, then those cities/townships with whom an agreement is not reached must receive the default allocation.

We have included an example in Section C.

#### When do counties need to allocate funding to municipalities/townships?

Counties must distribute funds to cities and townships by December 31 of each year. If an agreement is reached where funds are not allocated to some municipalities/townships, then this deadline would not apply for those jurisdictions.

## If a local unit of government administers absentee or mail voting for state elections, would they also receive the additional 25 percent allocation in the odd year?

Yes. This 25 percent allocation applies every year, even if there is not an election in the jurisdiction for that year.

If a local unit of government only administers AB/MB for their elections in the odd year, but not for state elections in the even year, they would not be entitled to the 25 percent allocation.

It is the position of the OSS that the determination of whether a local unit of government is entitled to the 25 percent allocation should be made at the time that the funds are distributed by the county.

#### What can the VOTER Account funds be used for?

The funds can be used for any purpose that is directly related to election administration. The enabling legislation included the following categories:

- 1. equipment;
- 2. hardware or software;
- 3. cybersecurity;
- 4. security-related infrastructure;
- 5. capital improvements to improve access to polling places for individuals with disabilities;
- 6. staff costs for election administrators, election judges, and other election officials;
- 7. printing and publication;
- 8. postage;
- 9. programming;
- 10. local match for state or federal funds; and
- 11. any other purpose directly related to election administration.

#### What are the reporting requirements?

\*Reporting requirements take effect starting in December <u>2024</u>. Those first reports will cover the previous fiscal year (July 1, 2023 – June 30, 2024).

- By December 15 of each year, municipalities must report to the counties how their money was spent.
- By December 31 of each year, the county will report to the OSS how they and their underlying municipalities spent the funds.
- By January 31 of each year, the OSS must compile the reports from the county and submit a summary report to the legislature that identifies expenditures by county, city, and town and the purposes of each expenditure.
- Funds remain in the county and/or city/township account until they are expended.

The OSS is establishing a process for reporting on VOTER funds expenditures that will be in place well ahead of the December 2024 reporting deadlines. In the meantime, counties and municipalities

must maintain an itemized description of how their funds are being spent according to the general expenditure categories outlined above. Receipts and invoices should also be maintained.

#### **Greetings to St. Louis County Township Officials:**

The Minnesota Department of Transportation – State Aid Division has provided a notice of funding opportunity for the 2023 Local Road Improvement Program (LRIP). You can visit the LRIP webpage at

http://www.dot.state.mn.us/stateaid/lrip.html. LRIP is established through Minnesota Statutes 174.52. There is \$102.967 million in funding available for the 2023 LRIP solicitation. Projects should be ready to be constructed between 2024 and 2026. The following is a summary of LRIP including opportunities to learn more through upcoming webinars.

#### Key Dates...

- Solicitation opens Tuesday, September 12, 2023
- Applications are due Friday, December 8, 2023
- LRIP Advisory Committee meets to review/recommend applications on March 14, 2024
- Awards are anticipated to be announced March 29, 2024

- Counties
- Cities
- Townships
- Federally Recognized Indian Tribes

#### Types of eligible LRIP projects...

- New construction
- Reconstruction
- Reconditioning

#### Funding accounts included in LRIP...

- 1. Trunk Highway Corridor
  - a. Purpose: Provides funding for local agency costs associated with a state trunk highway project.
  - b. Eligible Roads: All local roads, including township roads.
- 2. Routes of Regional Significance
  - a. Purpose: Supports economic development, capacity or congestion relief, provide connections to interregional corridors and other highways, and eliminate hazards.
  - b. Eligible Roads: County roads, city streets and township roads.
- 3. Rural Road Safety
  - a. Purpose: Reduce the frequency and severity of crashes.
  - b. Eligible Roads: County State Aid Highways only. Township roads are not eligible.

In summary, townships are eligible to apply for funding under the <u>Trunk Highway Corridor</u> and <u>Routes of Regional</u> Significance accounts.

#### **County Sponsorship Requirement**

Townships <u>must</u> obtain sponsorship of their project by St. Louis County prior to submitting their LRIP application. This requires townships to obtain a county board resolution from the St. Louis County Board of Commissioners. LRIP applications submitted without this sponsorship will not be considered by State Aid. St. Louis County would act as the fiscal agent for awarded township projects and project costs would flow through St. Louis County. *To ensure you obtain the county board resolution prior to the application deadline, you must submit a request to St. Louis County for sponsorship by Wednesday, November 1, 2023.* If you have questions about a proposed project, you can reach out to the following staff at St. Louis County...

#### **Engineers Cost Estimate**

LRIP applications must include an engineer's cost estimate. This cost estimate should be prepared by an engineer. Townships are encouraged to contact a local engineering consultant to prepare this cost estimate. St. Louis County is not able to prepare cost estimates for townships. Preparing a cost estimate takes time. Therefore, if your township is considering applying for LRIP, you should begin this work ASAP so the cost estimate is completed by the end of November.

#### **Maximum Funding Request**

The maximum funding request is \$1.5 million per project. A local match is not required. For an awarded township project, the township would be responsible to pay up-front project costs and then they would receive reimbursement of costs after a reimbursement request is submitted and approved by State Aid.

# Breitung Police Narcan Policy

In compliance with Minnesota state statute 626.8443, all Breitung Officers shall carry opiate antagonists (Narcan) in their duty equipment during their shift. The squad will also carry two doses as well. Officers are required to train on its administration and signs of an overdose. The Breitung Police Department will provide said training for the Officers. It is the responsibility of the Chief of Police to maintain an adequate supply for the Breitung Officers. It is the Officers' responsibility to notify the Chief if their opiate antagonist (Narcan) was administered during the commission of their duties. Each Officer shall carry two doses to be "readily available."

In compliance with Minnesota state statue 157.37 sub. 12, it is authorized that all Breitung Officers can/will deploy an opiate antagonist (Narcan) when they believe someone is suffering from a narcotic overdose.
