#### **Old Business:**

#### Infrastructure Projects

<u>2022-</u>Poplar St, Spring Road and Church Street are underway. Mesabi Bit currently doing trail work and should be back to finish up this Friday and next week.

2023-1st Avenue and Church St on hold. Currently have \$75k CDBG money committed and cannot apply again till this money spent. CDBG will likely need to be extended. Can possibility just use CDBG funds and change the scope of project. Chairman Tomsich ready to talk with IRRR again. IRRR can scores higher on application, the higher the funding request is. 250k can be awarded on projects of 1.5M and above and Breitung asked for 250k on a 626k project. IRRR also more likely to approve 250k if loans from USDA taken. JPJ is aware of project qualifying for USDA. Would need a new Median Income done, and would need resident participation if going this route. USDA offers more loan dollars than grant dollars. Will look to see where costs can be reduced (there are 2 cost estimates, possibly reduce 1 of the 2). PFA a possibility, but may be needed for Mesabi Trail project as the pipe under the bridge needs to be changed, and may need to take a draw. Supervisor Tuchel to work with Public Works Supervisor Gorsma to review and update 5-year plan

Motion by Supervisor Tuchel to apply for 75k grant through IRRR  $2^{nd}$  by Supervisor Tekautz

Clerk Sundahl to prepare a draft resolution by next meeting

Outdoor Recreation Project-McKinley Park

Representative from Flagship Recreation coming on Monday 08/28 at 8am. Will take measurements during meeting. Chairman Tomsich and Stephanie Ukkola will be meeting at the Park, and also looking at the Soudan Recreation area. Hoping to be complete at the Park by May of 2024. Playground equipment currently 23k. Currently have a Culture and Tourism Grant through IRRR for various projects for 18k, St. Louis County has set aside 20k in a grant, and \$7500 will be coming from Stuntz Bay Association.

<u>Care Crossings Update-</u>Received notice from the County that the Vermilion Park Inn has a Conditional Use Permit, originally applied for under Parkside. Care Crossing would still need to apply for their own Condition Use Permit.

#### Police Department Updates

- Impounded Vehicle 2015 KIA Truck-Chief Reing still waiting on paperwork
- <u>Goombaz Updated Security Proposal-</u>Chief Reing will work on Safety Grant, and Board will review once application is completed. Grant deadline is October 15<sup>th</sup>.

<u>Housing Institute-</u>Clerk Sunsdahl has participated in the first forum held in Grand Rapids, and one meeting held at Tower City Hall. 2 webinars coming up in September that she will attend. Just starting to look at housing options and prioritize.

<u>Water Filtration Plant-</u>TBWWB going through a series of studies. Total Project Cost Estimate is \$5,597,500 with a loan of \$768,000 over 20 years at 2% interest. Loan repayment would be 40k a year. TBWWB to collect revenue to pay for this project and payback loan. There would be additional operating costs such as energy, and additional testing. Operations not looking to increase. Any additional funding would reduce the \$1,082,000 of the project, not the loan. Motion by Chairman Tomsich to approve the project to go out to bid through the TBWWB  $2^{nd}$  by Supervisor Tekautz



## Warning on Scams and Cyber Security

MAT and various townships have recently seen multiple email and phone call scams. It appears to be a voicemail from a customer, and asks you to click to listen to, download, or mark as read. It may come from "Switchvox Digicloud.net" saying "(+19526530764) has left you a message 36 second(s) long".

This is a scam. Do not click on the links in the message.

## **MAT-U Update: Now Free for 2024!**



MAT is excited to announce that our new <u>online</u> training model: MAT-U, will continue to be free in 2024, as it has been in 2023. These online training videos give our officers greater access

to all training materials at any time!

The content is geared towards new MATIT systems, clerk and treasurer duties, and general township operations. All officers are welcome to submit suggestions and requests for specific or specialized training, as we will continually be creating and uploading new content. Videos, zoom recordings, PowerPoints, and handouts will all be available.

MAT-U is an annual subscription model with one master account for each township that allows all of your township officers to access the content library. After you sign up, your township's login credentials will be sent to the email provided, along with a link you can use to access MAT-U. It is best to use a township email when signing up, if possible. All officers in your township will use the same email for their usernames when accessing MAT-U. If you haven't already signed up for MAT-U, please register for MAT-U online here.

News from MATIT: New Workers' Compensation Legislation Requires Employers To Be Better Listeners



Effective August 1, 2023 an employee may now verbally request or notify their employer of their plans to obtain nonemergency surgical treatment for a work-related injury. If the employer or their workers' compensation provider fails to respond in writing within seven calendar days of the request or notification the employer or their workers' compensation provider may be responsible for the cost of the treatment regardless of its necessity.

Previously an injured employee, their treating physician or legal representative were required to submit a written request and secure approval before undergoing nonemergency surgery. This requirement allowed the employer or their workers' compensation provider the opportunity to evaluate the request and when appropriate seek a second opinion before agreeing to pay for the treatment.

With this change, it is critical that the township **IMMEDIATELY** contact MATIT's workers' compensation provider, SFM Risk Solutions (SFM), when an employee tells you they are planning on seeking any kind of surgery for an injury sustained while working for the township.

If the injury has already been reported to MATIT/SFM contact Adjuster Julie Peterson at **Julie.peterson@sfmic.com** or 952-838-4234.

If this request arises from a new injury report the claim by going to the MATIT website at <a href="https://www.matit.org">www.matit.org</a>:

- 1. Click on Claims
- 2. Click on Workers' Compensation
- 3. You will be taken to the SFM site.
- 4. Enter Policy Number 16204.
- 5. Enter the required information. SFM will use this information to set up a claim file and make the necessary reports to the State of Minnesota.

If you cannot report online, you have two other ways to report injuries to SFM:

**Report by fax**: Complete Minnesota 's First Report of Injury (FROI) and fax it to (800) 944-1169. Keep your fax confirmation sheet as evidence that you reported on time. You can find the Minnesota FROI at <a href="https://www.matit.org">www.matit.org</a>. Click Claims. Then Work Comp.

**Report by phone**: Call (800) WC-CLAIM [922-5246] to report an injury by phone. Regardless of how you report the claim, SFM will contact you within 24 hours of reporting a claim.

The LRIP program provides funding assistance to local agencies and federally recognized Indian Tribes for construction, reconstruction, or reconditioning projects.

#### **LRIP Solicitation and Schedule**

From the 2023 legislative session, a combined total appropriation of \$102.967 million in Local Road Improvement Program (LRIP) funds consisting of general obligation bond funds and general funds are available for this competitive solicitation, at least \$6 million of which must be for grants to townships. The solicitation will be released on September 12, 2023, and applications are due on December 8, 2023. We anticipate announcing LRIP selections by the end of March 2024, however, exact dates will depend on the number of applications received. Based on direction from the LRIP Advisory Committee, the maximum grant award has been increased to \$1,500,000 for counties, state aid cities, non-state aid cities, townships, and federally recognized Indian Tribes.

- Projects that have received legislatively selected appropriations ("earmarks") or previous LRIP grants are not eligible for funding under this solicitation.
  - Projects that will be awarded and/or under construction before the anticipated LRIP selection notifications in March 2024, are not eligible for funding under this solicitation.
  - Projects should be non-controversial and should be construction ready in 2024, 2025, or 2026.
  - County applications will be evaluated against other county applications; state aid city
  - applications against state aid city applications; and small city/township/federally recognized Indian Tribes applications against small city/township/federally recognized Indian Tribes applications. We anticipate funding projects from all three agency types.
  - The expected useful life of improvements must be a minimum of 10 years.
     Maintenance type activities such as filling potholes, blading gravel roads, and standalone ditch repairs are not eligible for LRIP.
  - Items that are eligible for LRIP funds include reasonable elements associated with roadway construction, including basic landscaping and turf establishment. Landscaping planters, benches, bike racks, decorative fences, ornamental lighting, and other aesthetic treatments above the standard are generally not eligible. Other items that are not eligible include engineering, construction administration and inspection, right of way acquisition, and water main, sanitary sewer, or private utility work.
  - LRIP funds cannot be used for improvements on the Trunk Highway system, including those costs that might be required from a local agency on a Trunk Highway project as per MnDOT's Cost Participation Policy.
  - County Sponsorship
  - Consistent with previous solicitation requirements, State Aid will require counties to sponsor projects on township and non-state aid city roads. See

#4 under Project Selection in the LRIP Solicitation Guide for more information on duties associated with this requirement. This is required (1) to provide engineering, plan development, contract administration, and grant agreement expertise to townships and small cities, and (2) to help ensure that the improvements will be constructed on time and within budget. Townships and small cities should be in contact with their county engineer on potential applications.

## **PERA Survey: Membership Salary Threshold**

Effective July 1, 2023, the earnings threshold for PERA's Coordinated, Correctional, and Police & Fire defined benefit plans (DBPs) is \$425 paid in a single month. This applies to all employer types and replaces the annualized threshold of \$5,100 for local government and \$3,800 for school-year employees.

The purpose of this earnings requirement is to provide PERA membership to employees in recurring or regular positions. The current \$425 monthly threshold rate has not been increased since 1988. PERA is reviewing the monthly threshold and may bring forward changes in a future legislative session.



# Community Development grants support the opening of a new eye clinic in Hibbing



Eye Clinic North opened a new 4,000 square-foot office along the main commercial corridor of Highway 169 in Hibbing last week. The clinic relocated from a 1,000-square-foot office in downtown Hibbing which was no longer adequate to meet their needs. The new location has seven exam lanes, two optometry providers, five staff members and room for more providers and staff as they grow. The former location had only two

lanes, one provider and four staff.

Iron Range Resources & Rehabilitation supported the project with a \$300,000 Development Infrastructure grant and a \$100,000 Commercial Redevelopment grant to the city of Hibbing. The Development Infrastructure grant helped with site and infrastructure work. The Commercial Redevelopment grant helped mitigate the brownfield property for redevelopment by adding four feet of correction soil. The 1.4-acre property was abandoned and had served as a city dump area from the 1940s to the 1960s. Dr. Matthew Sipola and his wife Hannah, also a licensed optometrist, purchased the lot and divided it in half. The new eye clinic sits on one lot. The other lot is for sale with the intent to attract another medical or health facility.

"We were excited to partner with Iron Range Resources & Rehabilitation and the Drs. Sipola on this project to reclaim a contaminated site on the beltline in Hibbing," said Mayor Pete Hyduke. "We're happy to work with any business who is willing to invest in our community."

The agency also provided \$40,000 in Business Energy Retrofit (BER) and \$10,000 in Downtown Building Rehabilitation (DBR) grants to the Sipolas to help pay for new energy efficient optometry equipment and other materials.

"The new location is larger and centrally located. By expanding and adding more providers and staff, our clients will have shorter wait times for their eye care," said Dr. Matthew Sipola. "And being the only full-time medical eye clinic in the Hibbing area, we are often solely responsible for treating patients with urgent or emergent eye care needs, such as red, painful eyes and foreign bodies. The new clinic better serves the entire Hibbing community for



both routine and emergency care. It is important to us to better serve the needs of the assisted living and those with limited mobility, and we are able to do so with our fully ADA compliant facility."

The new Hibbing location is one of three Eye Clinic Norths. The other two locations are in Virginia and Duluth, and all are owned by the Sipolas. The clinics offer a wide variety of services, from family eye care and contact lenses to management of complex medical eye conditions and access to world-class LASIK technology and surgeons.



The Sipolas purchased the original Hibbing location in 2016 from Dr. Scott Mescher. This year marks 104 years of continuous operation as optometry. The same year the couple purchased the Virginia and Duluth offices from Matt's father, who succeeded his father. Drs. Matt and Hannah incorporated the three offices into Eye Clinic North.

# Nashwauk Township completes second phase of playground renovation at community center





# **Updated prevailing wage requirements for Minnesota state agency grant recipients**

Construction projects funded in whole or in part with state dollars, must adhere to prevailing-wage requirements under the MN Prevailing Wage Act (MPWA) and pursuant to Minnesota Statutes § 116J.871. As a condition, state of Minnesota contractors and subcontractor(s) are required to complete and submit certified payroll records to the contracting authority.

Effective July 1, 2023, Minn. Stat. § 116J.871, subd. 2(b) deems the state agencies awarding financial assistance to be the "contracting authority" responsible to collect the certified payroll records.

Consequently, the Department of Iron Range Resources & Rehabilitation is required to collect certified payroll records for all grants where prevailing-wage requirements apply.

Going forward, all projects funded by the agency where prevailing-wage laws apply will require certified payroll records be provided by the grant recipient prior to the agency disbursing funds.

Recipients of financial assistance from state agencies should contact the Department of Labor and Industry for applicable prevailing wage rates and guidance on how to comply with prevailing wage requirements in Minnesota

Statutes, section 116J.871 and the MPWA, Division of Labor Standards and Apprenticeship.



The trail is also the newly re-routed Nashwauk Snowmobile Trail. Iron Range Resources & Rehabilitation supported the project with Regional Trails grants totaling \$105,500 to Itasca County Land Department. Total project investment was \$311,500.

Hardy passed away in 2018 and left a long record of service to his nation and local community. He served on the board of the All-Terrain Vehicle Association of Minnesota, was



president of the Itasca County ATV Alliance and helped create 19 ATV clubs throughout the region. For his role as a Minnesota Department of Natural Resources (DNR) Trail Ambassador, Hardy promoted ATV education and safe riding, especially among youth. During that time, the DNR named him their Volunteer ATV Safety Training Instructor of the Year. He was a licensed contractor who built and maintained numerous roads and trails in northern Minnesota, including the development of the first two ATV trails in Itasca County. Hardy served 22 years in the Army National Guard as a member of the 47th Aviation Battalion.



To celebrate the opening of the new trail, Range Riders ATV Club hosted a dedication ceremony on August 23 at the Nashwauk Veterans Memorial Park. Nearly 60 people attended the event including Hardy's two children and his granddaughter. Following the dedication, the attendees rode to the sign at the new trail for a ribbon cutting and then headed out on the trail.

"Nashwauk was not previously linked to a trail system, so the new nine-mile stretch of trail is a very important connector," said Sara Thompson, Forest Recreation Specialist with Itasca County Land Department. "The trail traverses through forest and crosses a 260-foot boardwalk. Riders have a scenic view of Blue Lake and may access views of Hawkins and LaRue Mine Pits within the city limits of Nashwauk."

Thompson explained that the amount of ATV trails and riders has increased in Itasca County and in Minnesota. The result has been an increase of local and visiting riders as more trails have developed throughout the region, which means a positive impact to local communities and the economy.

# Cuyuna school develops mountain bike trail and outdoor learning area



A beginner mountain bike trail and learning space was completed last month on the Cuyuna Range Elementary School (CRES) grounds, providing Crosby area youth the opportunity to develop mountain biking skills. The trail will also be used for preschool through 6th grade students to hike, snowshoe and cross country run. Teachers and students may utilize the trail as an outdoor classroom for studying nature, bird and animal watching. The trail is also open to community members. Iron Range Resources & Rehabilitation supported the project with a \$43,200 Regional Trails grant to the city of Crosby. Total project investment is estimated at \$86,400.

The school's biking program began several years ago when two CRES teachers set a goal to provide biking to students at the school and within the Cuyuna community. Clayton Lang and Lori Vosacek raised approximately \$38,000 through grants and donations to purchase a fleet of 40 mountain bikes and a trailer so that third through sixth grade students could be taught basic biking and mountain biking skills. The bikes were initially utilized in physical education class on the school's baseball and football fields. The fleet was also utilized for a free summer mountain bike camp, Range Riders. The idea was soon conceived to build a multi-purpose trail on school property to continue the biking program's momentum.

The school is located near the Cuyuna Country State Recreation Area (CCSRA) which is spread across 800 acres surrounding reclaimed mining lands. There are 50 miles of mountain bike trails with scenic vistas.

"We live in an amazing community where people come from all around the state and region to enjoy our trails," said Lang. "The school trail and learning area allows us to teach students how to bike safely with the proper equipment before accessing other trails the area has to offer. We are also able to introduce students to an activity they can participate in for life."





Lang explained that learning to maintain trails as a community resource is necessary to enrich the Cuyuna area as a mountain bike destination. The trail experience being provided at the school gives students a greater understanding of trail stewardship.

"The community support for this project was tremendous," said Lang. "We were able to create an awesome space to teach mountain bike skills to students in our Cuyuna community. The kids are also learning about something that is very central to our region's economy."

# Knife River restores historic fish tug to recognize the North Shore's commercial fishing industry and its fishing families



A new commercial fishing exhibit was added at the Knife River Heritage & Cultural Center (KRHCC) this summer. A 35-foot gas-powered fish tug that fished out of Knife River for many years, the *Crusader II*, was restored and is on display along with five weather-proof interpretive displays. The fish tug was gifted by the Lake County Historical Society. From the early 1990s until gifted to the KRHCC, the boat was on Lighthouse Point in Two Harbors as a visitor attraction but had fallen into disrepair.

The new exhibit traces the history of Lake Superior's North Shore commercial fishing back to the early 1600s when Europeans began trading for furs and fish with Native Americans. Iron Range Resources & Rehabilitation

supported the project with a \$30,000 Downtown Streetscapes grant. Total project investment was \$68,700.

Crusader II rests on its cradle on a 26 by 48-foot slab with an ADA-compliant viewing deck that allows visitors to see its interior. Five, two by three-foot interpretive displays are mounted on the viewing deck. They chronologically describe Knife River's Native American presence, the arrival of Europeans (mostly Scandinavians), history of Crusader II and how commercial fishing shaped the character of Knife River. A shelter over the boat and the viewing deck with its displays will be built next spring.

According to Lake County Historical Society, *Crusader II* was built in 1939 and christened by Crown Prince Olav of Norway during his visit to the North Shore that same year. The boat was built by Reuben and Helmer Hill of nearby Larsmont, Minn., owned by Carl Erickson of Knife River and used until 1953 for harvesting trout and herring. It was later used for charter fishing.

In addition to *Crusader II*, KRHCC is home to the historic Knife River train depot and the Viking ship *Leif Erickson*. The depot's exterior and interior were previously restored to make it a fully functioning 1900s depot and open to the public. A previous Cultural & Tourism grant from Iron Range Resources & Rehabilitation helped rebuild the depot.



The *Leif Erickson* was in Duluth's Leif Erikson Park for more than 90 years before the city gifted it to a non-profit that relocated it to the KRHCC in 2021. Restoration on the Viking ship will begin next spring.



"The preservation of the three historic icons will create a significant North Shore historical and educational attraction," said Paul von Goertz, KRHCC president. "The center is committed to preserving the past so that people, especially younger generations, can learn about the history of Knife River and the commercial fisherman of Lake Superior. Our region's history has shaped our communities and people today, and it is vital that we understand it and cherish it so that it


does not fade away."

A number of visitors to the KRHCC arrive by train on the North Shore Scenic Railroad. Upon arrival, guests may tour the depot and boats. Adjacent to the depot area is a large agate beach where people can hunt for the official state gemstone as designated by the Minnesota Legislature in 1969.


The Knife River community is in Lake County along the North Shore Scenic Drive of Lake Superior between Duluth and Two Harbors. The township of 230 people is at the mouth of the 23.9-mile-long Knife River which drains into Lake Superior. The community's name is speculated to have been given by the Ojibwe Native Americans due to the long, sharp stones in the river.

Other project partners included the Lloyd K. Johnson Foundation and Lake Country Power & Light.

Beginning last year, the Downtown Streetscapes grant merged with the Culture & Tourism grant and has a fiscal year budget of \$600,000. <u>Email Danae Beaudette</u> or call her at 218-735-3022 for Culture & Tourism grant information.



# Virginia Market Square adds performing arts venue



The Virginia Market Square farmers market added a wood band shelter and concert stage that will host performances during the market hours and at other special events. The new performing arts venue has electricity and lighting to accommodate a variety of local musicians and entertainers. Iron Range Resources & Rehabilitation supported the project with a \$2,500 Culture & Tourism grant to Iron Range Partnership for Sustainability. Total project investment was \$7,500.

Market Square is in its eighth season and operates May through October out of the city-owned Kline-Cuppoletti Park Facility on Silver Lake in the heart of Virginia. Area farmers and artisans sell locally grown fruits, vegetables, eggs, meats, canned goods and wild rice, along with homemade roasted nuts, coffee, baked goods, bug repellant, crafts and soaps. The new band shelter is located at the south end of the facility, and there are benches in the shade for audience members and market shoppers.

"The project enhanced the park area on Silver Lake and created an additional amenity at this historic site in Virginia," said Marlise Riffel, Virginia Market manager. "Farmers markets add to the quality of life in our community by strengthening agricultural economic development, fostering social gathering, and providing access to fresh locally grown foods."



# Over \$580,000 in Commercial Redevelopment grants awarded to business projects in Chisholm, Hibbing and Virginia

The cities of Chisholm, Hibbing and Virginia last week were awarded \$586,030 in Commercial Redevelopment grants by Iron Range Resources & Rehabilitation. The agency invests approximately \$1 million annually into the grant program across its 13,000 square-mile service area. The grants assist with the internal and external demolition of commercial and industrial buildings and clean-up of brownfields to pave the way for new development.



"Our local downtowns are vital to the Iron Range communities and impact both our economy and quality of life. We rely on them as places we do business and where we engage in cultural and social events," said Commissioner Ida Rukavina,

Iron Range Resources & Rehabilitation. "We were very pleased to support these three communities as they work to further revitalize their downtowns."

The recent grants include:

 City of Chisholm: \$120,000 to redevelop a vacant downtown property on Lake Street into a new business that operates as a gallery on the main floor and a rentable tenant space on the second floor. The building's interior must be completely refitted with new code compliant electrical, plumbing, heating and safety features. Total project investment is estimated at \$441,575.

"This is a great opportunity for the city of Chisholm to have a downtown building breathe new life. I am excited to welcome the new owners. I am thankful to Iron Range Resources & Rehabilitation and am thrilled to see the impact the commercial redevelopment grant will have on our community." – Chisholm Mayor Adam Lantz

- City of Hibbing: \$200,000 to redevelop a building adjacent to Sammy's Pizza on Howard Street. The owners of Sammy's purchased the building and will expand their operation into the space once it is renovated. Total project investment is estimated at \$2,216,736.
- City of Hibbing: \$67,850 to redevelop a four-level building into short-term rentals and a food and entertainment establishment, The Iron House. Total project investment is estimated at \$492,350.
- City of Hibbing: \$18,890 to redevelop a building located on 4th Avenue East into a space that will be leased by The Hibbing Elks Lodge which operates a restaurant, bar and special event venue. Total project investment is estimated at \$325,548.

"In our recent Strategic Planning and Visioning sessions, the Hibbing City Council and Administrative team determined that the viability of downtown Howard Street is a top priority for our community. One of the main components is helping downtown business have access to funding to help make necessary improvements to their buildings. Whether it's new businesses looking to locate in downtown Hibbing or existing businesses looking to expand these building improvements help to maintain our historic downtown and keep it vibrant for today and into the future." – Hibbing Mayor Pete Hyduke

- City of Virginia: \$90,000 to perform emergency demolition on a commercial building owned by Pohaki Lumber who intends to reconstruct it as a multi-level commercial space with tenants. Total project investment is estimated at \$297,355.
- City of Virginia: \$84,250 to redevelop a building (formerly Goodwill)
   adjacent to Northeast Technical Services, Inc. (NTS) on Chestnut Street. The

- owners of NTS purchased the building and will expand their office and lab operations into the space once it is renovated. Total project investment is estimated at \$1,700,000.
- City of Virginia: \$5,040 to renovate interior portions of F&D Meats to allow for installation of new coolers and freezers. F&D is located in a 50-year-old building and has been operating in Virginia for more than 40 years providing fresh cut meats and groceries. The meat shop was recently purchased by new owners who have invested in the building to elevate the customer experience. Total project investment is estimated at \$93,099.

"The recent grants will increase commercial development, expand downtown business renovation, revitalize the local neighborhoods and eliminate blighted properties. Without the strong community commitment and ongoing partnership funding by Iron Range Resources & Rehabilitation, these projects and many others would not have been possible. The agency is an important economic driver for the Iron Range." — Virginia Mayor Larry Cuffe, Jr.

Several of the businesses applied for Business Energy Retrofit (BER) and Downtown Building Rehabilitation (DBR) grants for energy efficiency and codecompliant upgrades to their buildings. BER and DBR grants are awarded directly to small business owners and can assist with projects related to HVAC, electrical, plumbing, lighting, appliances, windows, doors, storefronts, ADA compliancy, lead and asbestos removal and fire suppressions systems. Both programs are funded by Iron Range Resources & Rehabilitation and administered through a partnership with Arrowhead Economic Opportunity Agency (AEOA). Learn more about BER and DBR.

Businesses seeking a site for an expansion or relocation are encouraged to talk to their municipality. Cities, townships, counties and tribal governments located with the agency's service area are eligible to apply for Commercial Redevelopment grants.

Iron Range Resources & Rehabilitation Community Development staff is available to answer questions and guide cities and businesses through potential projects which can range anywhere from a storefront on main street to a manufacturing business in an industrial zone.





# **RSV Vaccine Updates**

Respiratory syncytial (sin-SISH-uhl) virus, also known as RSV, is a common viral infection. It can cause respiratory illness in people of any age and is one of the most common diseases of early childhood. It can also cause severe illness such as bronchiolitis (inflammation of the small airways in the lung) and pneumonia (infection of the lungs). Typical onset emerges late September to mid-October with peak time generally in the first part of February, with cases generally wrapping up by first week of May each year. Lice



Emerging technologies continue to inform us with new methods and indicators to determine a population's overall month to month trends and health when it comes to viral illnesses such as SARs-COV2 and Influenza. Suzy Van Norman PHN DP&C recently had a conversation about wastewater with Roger Laaksonen, PH's IT Guru and purveyor of always so many helpful ideas and facts. He provided DP&C with a *fount* of information on the wastewater data over the course of the pandemic. Thanks to Roger for providing me with great info here!

Wastewater intelligence data across the country is one of those sources and helps inform our public health strategies and response for COVID-19, influenza, and RSV.

Every week, more than 35 treatment plants in Minnesota gather and analyze wastewater to monitor for SARS-CoV2 (COVID-19) and other virus prevalence. These plants cover nearly 67% of all MN residents. As children head back to school, and people begin to congregate more indoors as the temperatures cool, we often see a rise in head lice questions and cases across the county. Thought it would be helpful to give you a few informational talking points and resources to share with your clients about Lice.

#### What are head lice?

The head louse is an insect that can infest people. These tiny insects (about 1/8" long) make their home in human hair and feed on blood. Head lice multiply rapidly, laying small greyish-colored, oval-shaped eggs (called nits) which they glue to the base of the hair, close to the scalp. Head lice are not known to spread disease.

# How does a head lice infestation occur?

Head lice have no wings and do not fly or jump, but they can crawl or run through hair quickly. Most commonly, head lice are spread by direct head-to-head contact with an infested person. They may also be spread by sharing personal items such as combs, brushes, other hair-care items, towels, pillows, hats, and other head coverings. Dogs, cats, and other pets do not spread head lice.

You will find some links at the bottom of the MDH page for Wastewater. Check out the metro plant stats link on variant percentages, they are very good visuals of the metro area trends.

We love good statistical data here in DP&C, unfortunately the wastewater data for our region currently updates slowly so it is less useful in its anecdotal data for up to the moment needs. For example, the wastewater ppm for August 13 was a nice low 181 initially, but on or around 8/23 it updated to 1300. Still, we can look back vents, and test or replace those smoke at end of month and see the trend change in August.

It is helpful as we can look back at this year and see the upward trend in January and February to the very low June and July numbers. Another way to capture useful analysis may be to compare year to year data across the official period of the pandemic to see trends. We are hopeful this data will continue to improve its timely response to give us up to the minute data.

What can you do? Check your child's head frequently during the school year. Provide immediate treatment. Here are resources for sharing!

# NE MN HOME Consortium Public Meeting HOME Funding Process

The HOME Program was created by Congress under Title II (the HOME Investment Partnerships Act) of the National Affordable Housing Act of 1990 and is administered by the U.S. Department of Housing and Urban Development (HUD). The Program provides grant funds that offer flexibility to states and local governments to decide what kind of housing assistance is most appropriate for their housing needs. Eligible uses of the funds include new construction, rehabilitation, acquisition of standard housing, assistance to homebuyers, and tenant-based rental assistance.

The Northeast Minnesota HOME Consortium (Consortium) was formed in 1991-1992 through the signing of a Joint Powers Agreement by the county boards of Cook, Lake, St. Louis, Itasca, and Koochiching. These contiguous counties were needed to meet the qualifying population threshold required of the HOME Program. The Consortium, guided by a 10-member Advisory Committee that includes a county commissioner and another appointed representative from each county, receives an annual HOME Program allocation of about \$600,000. (Note: The City of Duluth receives separate HOME funding and is not included in the NE MN HOME Consortium.)

The Consortium will hold a public meeting of the HOME Investment Partnership's (HOME) Advisory Committee to review second round applications for fiscal year 2023 funding on Friday, September 22, 2023, from 10:00 AM- 12:00 PM. The meeting will be hosted at the Virginia Public Works Training Facility in the Lake Vermilion Conference Room at 7823 Hwy 135, Virginia, MN 55792.

ZoomGrants will streamline processes for both applicants and the Advisory Board. Each paperless application will be evaluated and scored online by Advisory Board Members based on how it meets the criteria listed in the scoring rubric located below. Pre-applications are due by October 13, 2024, by 4:30 p.m. ZoomGrants will automatically save responses and applications from year to year and allow multiple collaborators for each organization. The ZoomGrants webpage provides many training resources and contact information if additional assistance is needed. St. Louis County Community Development staff will also be able to offer support through virtual and in-person meetings. If you have questions about any part of this application, contact St. Louis County Community Development by email

# Funding for Lead Service Line Replacements and Other Resources

Reprinted from The Fall 2023 Waterline -Minnesota Department of Health Quarterly Newsletter

In addition to the \$240 million allocation from the state of Minnesota for the replacement of lead service lines, the federal Infrastructure Investment and Jobs Act - also known as the Bipartisan Infrastructure Law - provides approximately \$40 million per year for five years for replacement projects.

Public water systems may apply through the Drinking Water Revolving Fund.

Priority will be given to areas with children under the age of five and/or children with elevated blood lead levels and areas with lower-income residents or disadvantaged communities. In addition, removal of lead service lines that are an imminent threat to public health and safety will be prioritized as will the replacement of lead service lines in coordination with watermain replacement projects.

Water systems are encouraged to apply for funding as soon as their lead service line inventories are complete. The University of Minnesota has a mapping tool that can help with these inventories.

MDH estimates that there are approximately 100,000 lead service lines in the state. "Safe, clean drinking water is a foundational human need, and it is long past time we make it a reality for all Minnesotans," said Governor Walz when he signed the legislation.

Lead service line inventories dues October 16, 2024

As mandated by the federal Safe Drinking Water Act, all community and nontransient noncommunity water systems must prepare an inventory of all service lines (including those not in use) that are connected to water mains. These inventories, which are due to the Minnesota Department of Health by October 16, 2024, must include a location identifier and the material of the service line.

The first step in a process to remove lead service lines, the inventories will be regularly updated as additional information becomes available and as lead service lines are removed and replaced.





I am pleased to inform you that the Minnesota Public Facilities Authority (PFA) approved project financing for Breitung Township on September 1, 2023. # Breitung Police Narcan Policy

In compliance with Minnesota state statute 626.8443, all Breitung Officers shall carry opiate antagonists (Narcan) in their duty equipment during their shift. The squad will also carry two doses as well. Officers are required to train on its administration and signs of an overdose. The Breitung Police Department will provide said training for the Officers annually as required by state statute. It is the responsibility of the Chief of Police to maintain an adequate supply for the Breitung Officers. It is the Officers' responsibility to notify the Chief if their opiate antagonist (Narcan) was administered during the commission of their duties. Each Officer shall carry two doses to be "readily available." If the opiate antagonist (Narcan) is administered by the officer, ambulance personnel shall be notified and dispatched as soon as the officer is able to do so.

In compliance with Minnesota state statue 157.37 sub. 12, it is authorized that all Breitung Officers can/will deploy an opiate antagonist (Narcan) when they believe someone is suffering from a narcotic overdose.





# Township of Breitung Road Improvement Project

## Summary

This project is to improve our township owned road by reconstructing the existing road from the middle of our sand and gravel operation to the eastern edge of our property line. The benefits of this improvement are:

- Provide safer access from State Highway 169
- Eliminate the system deficiency in the present sand and gravel operation
- Create a safe connection trail to the new State Park ATV campground
- Support economic development and congestion relief

The budgeted cost of this project is \$500,000 with the substantial completion date set at June 30, 2025.

#### Safe Access

The relocated entrance/exit of our road will provide for improved site lines, proper acceleration bypass lanes and elimination of the existing entrance which is located on a curve at the crest of a hill on HWY 169. The current road serves two separate sand and gravel operations: our own township and an active private construction firm and also private landowners further down the road. The activity of construction and gravel equipment leaving and entering the existing road is especially hazardous due to the curve and hill at Hwy 169. The majority of this work occurs during the same time of increased traffic due to seasonal travelers visiting the area only adding to the likelihood of conflict at the Hwy 169 entrance.

# Present system deficiency


Our township's sand and gravel operation has developed to the point of reaching the boundary of the existing road which dissects our pit property. The current operations are limited to further development until the road is relocated. Additionally, the private operator is disadvantaged due to their equipment having to connect to the existing road on a curved entrance. Relocating our road will provide for proper pit development and allow for improved use of our sand and gravel resources over the next 50 years. The private operator will have a direct exit from their pit operations to the new road and both operations will be more productive with the new HWY 169 access point.

# Safe connection to new State Park ATV campground

Our township is home to Minnesota's newest state park and as it is being developed out the need for a new campground for ATV vehicles was funded by the legislature and planning is currently underway by the DNR. They have approached us with the need to connect the trail from the campground to the access point further down our existing road. This relocated road will provide a safe and highly visible route for the ATV riders with minimal interaction of the sand and gravel operations. The route of the new road is the safest alternative and will reduce or eliminate the potential of traffic crashes, injuries and property damage. The campground is planned to be operational in 2025.

## Support economic development and congestion relief

The popularity of the new Lake Vermilion Soudan Underground Mine State Park continues to grow each year and improving this road will raise the positive experience the visitors have while exploring our area. ATV use is on the rise and accommodating this economic pastime with a safe and enjoyable connection will support the local economy and direct ATV traffic to the designated trails and reduce the congestion of ATV's, vehicles and pedestrians on residential streets. Local residents will especially notice the improvement of living in the area with a safer MN Highway 169 entrance and exit as they go about their daily trips in local towns with minimal ATV traffic interference. Improvements in the sand and gravel operations and relocated road will result in efficiencies in providing necessary resources for further development in our area.


