#### Phishing Scam:

There is a new phishing scam going on now directed at townships. The email says it is from the "IRS" saying they haven't received the townships W-2s for 2020. <u>Do not call</u> the phone number on the email or letter if received via USPS. Call the IRS directly using a phone number on their website. This scam is asking to re-send the W-2's and asking for a fee.

Please be vigilant in looking at your emails before you open any attachments or call anyone. MAT will keep our membership informed when we have knowledge of what is going on.

#### CTAS:

I have been fielding quite a few questions regarding voiding checks in CTAS. You do not void checks in claims, you must void them in disbursements. The claims module is a holding place for bills to be paid. Once paid they become disbursements and any changes, voiding or deleting are to be done in disbursements module. Remember, CTAS is very date sensitive, so if you are running reports and something that should be there is not showing, your first step will be to ensure that the date of the transaction is correct. ## News from MATIT: Risk Management as Mission Readiness



#### **View Print Version of this Article**

As it relates to Township Governance – Risk Management ensures Mission Readiness. What follows is a brief explanation of the Risk Management process. In honor of Veteran's Day – and in the interest of making the material relatable – I have included various terms my fellow Veterans may be familiar with. However, I will make sure to perform a language C & S (Clean and Sweep) for the CP (Civilian Personnel).

Now, as I am a former Zoomie, these terms may not have the same application to Grunts, Squids, Leathernecks and/or Jarheads – **HUA** (Heard, Understood, Acknowledged), Hoorah! and Huah!

What is Risk Management?

It's been referred to as many things depending on your **MOS** (Military Occupation Specialty) or **AFSC** (Air Force Specialty Code) – it may be:

COA (Course of Action)

**SOP** (Standard Operating Procedures)

ISR (Intelligence, Surveillance, Reconnaissance)

ROE (Rules of Engagement)

PMS (Planned Maintenance Schedule)

Whatever it was called, the essential goal of both Risk Management and Mission Readiness is the 7Ps - (Proper Prior Planning Prevents Pathetically Poor Performance). If you didn't want your next **EPR** (Enlisted Performance Report) to reflect a rating of **UNSAT** (Unsatisfactory); you made sure your unit was **FMC** (Fully Mission Capable) – and in my case an **OA** (outstanding Airman)!

This is a process of identifying, analyzing, controlling, and monitoring events. It is an ongoing cycle, ensuring resources are focused on the areas of greatest consequence to the township.

Risk Identification – **SA** (Situational Awareness)

As it relates to township governance, what keeps you up at night? When you think about it you break out in a cold sweat? What issues does the township face? Breakdown of equipment? Planning and zoning disputes? Lack of residential engagement/residential apathy? Something else? Make a list of those to discuss at an upcoming board meeting. For the purpose demonstration in this exercise, I will use the risk of Succession Planning – the ability to fill township offices as existing occupants leave office.

Risk Analysis – WCS (Worst Case Scenario)

How likely are those nightmare scenarios to occur **AND** then what? If a nightmare scenario occurs, what does that mean for the township? Purchase of additional expensive equipment? Exposures from lawsuits? Will the newspapers write negative stories about the township/board? The key to this step is using uniform scoring systems, applicable to all risks identified. For example, scoring "likelihood" and "impact" on a scale from 1 (lowest) to 5 (highest) – the product of these will be the "risk score."

If the officers of a township are not replaced, the effects could potentially be devastating for the future of the township. Unfilled, or filled with the wrong person – the board may become hostile to the existence of townships. Scoring may look something like this:

Risk Event	Likelihood (1-5)	Impact* (1-5)	Risk Score (L*I)
Township office(s) are unfilled.	5	3	15
Hostile actor wins township office(s).	2	5	10

<sup>\*</sup>Any agreed upon metric can be used for Impact (money, downtime, reputation, press exposure, etc.)

Risk Control – C2 (Command and Control)

"Controls" are meant to either prevent an event entirely **or** minimize the likelihood and/or impact. What can be done to prevent identified risks from occurring? Ensuring proper procedures are in place and record keeping when it comes to board decisions? Placement of signage when grading roads? – OR – If these risks are inherent to operations (when working around rocks, damage will occur), what efforts can be used to reduce the impact? The townships officers in place today should be encouraging and mentoring, members of the public they would like to serve as future township government leaders. Engagement with residents is a measure critical to facilitating the future of the township. Make sure the residents are considered when setting meeting dates and times, publishing meeting notices (could they be posted online?), and perhaps try different date/times to see if participation increases.

Risk Monitoring – **TBD** (To Be Determined) Identified – Oorah! Analyzied – Yut! Controlled – Aye, Aye!

Did it work? How do you know? Do it again! Identify, Analyze, Control... While the list of exposures may not have changed, did the controls applied adjust either the likelihood and/or impact? Does that change the overall risk score? Can additional steps be taken to further reduce the score?

This won't be a board item every month. Once identified – the discussion on mitigating risks may only be once or twice a year. Do not get hung up on one risk, scoring, or trying to eliminate risk altogether. The conversation in the process is what is important. Leverage strengths, fortify weaknesses, and work together with other municipalities (other townships, county, state, federal) to mitigate (not eliminate) risks. Everyone faces similar issues, share what has (and has not!) worked, compare "war stories."

Remember – "I am a soldier. I fight where I am told, and I win where I fight." – Lt Gen George S. Patton

To all the Veteran's currently serving in township office – Thank You, for your service. To all the spouses and **brats**\* (Born, Raised, And Transferred) – invaluable but often overlooked, who served alongside – Thank You, for your sacrifices – we couldn't have done it without you!

## Use e-Services to Create a Certificate of Rent Paid

The Minnesota Department of Revenue is expanding access to their Certificate of Rent Paid (CRP) system. By January 1, 2024, all residential property owners and managers will be able to log in to e-Services. There is no cost to use this service.

Landlords are not required to use e-Services to create CRPs for rent paid in 2023. However, landlords will be required to use e-Services to create CRPs for rent paid in 2024.


#### 2023 LRIP (Road) Funding and Upcoming Webinars

# Range Steel Fabricators acquires new equipment to meet client demand

Range Steel Fabricators (RSF) added a new Okuma Genos M560-V 4-axis vertical machining center (VMC) to its operations. The VMC decreases production time and increases quality of finished products for one of RSF's largest customers. Iron Range Resources & Rehabilitation supported the equipment acquisition with a \$78,000 loan to RSF. Total project investment was \$163,500.

The new VMC replaced an older inefficient machine. The computerized VMC makes component parts utilizing 4-axis milling, has a 32-tool magazine, and offers excellent cutting



performance, accuracy and repeatability. It can handle a variety of materials from steel to titanium to aluminum.



RSF machines and fabricates steel and aluminum components and supplies them to industries such as energy and utilities, mining and minerals, paper and forest products, commercial construction, heavy equipment and industrial manufacturing. Local companies use the components from RSF to assemble their products that are then sold and shipped all over the world from northeastern Minnesota.



# Chisholm renovates apartments, increases housing stock



The Chisholm Housing and Redevelopment
Authority remodeled eight efficiency apartments
located within one building that was built in
1960. The renovation of the Mapleview
Apartments included new heating, electrical,
plumbing, insulation, sheetrock, venting and roof
upgrades, kitchen and bath cabinets, fixtures and
countertops. Iron Range Resources &
Rehabilitation supported the project with a

\$210,000 Community Infrastructure grant. Total project investment was \$784,421.

The eight apartments were all original and in need of upgrades. The renovated apartments meet modern building codes, expanded the affordable workforce housing

stock in Chisholm and align with the city's comprehensive plan. Mapleview offers one-and two-bedroom units and is located within walking distance of downtown.

The Chisholm HRA was founded in 1949. The organization oversees the city's public housing totaling 155 units on five sites across the city, including Mapleview Apartments.

Other Mapleview project partners included Chisholm HRA, St. Louis County HRA and the Community Development Block Grant Program provided by the U.S. Department of Housing and Urban Development.

#### Housing grant applications now open



This year Iron Range Resources & Rehabilitation made available \$5 million for a new Housing grant to help address the regional housing shortage. The new Housing grant assists projects or programs that result in the creation of new housing units or the rehabilitation of existing housing units. The program supports housing solutions that align with local priorities and regional employer's needs.

The grant cycle is open now through May 31, 2024 or until program funds are substantially committed, whichever occurs sooner.

Cities, townships, counties, nonprofits and tribal governments are eligible to apply. All grant funds must be spent within or for the benefit of the agency's service area.

Examples of eligible projects include but are not limited to:

- Infrastructure and site work of new housing developments on vacant and redeveloped land.
- Repurposing non-residential buildings for residential use.
- Rehabilitating existing single family and multi-family housing and funding for housing trust funds or programming to support local workforce housing initiatives.

A one-to-one match per project is required. Applications should be submitted nine months prior to the project construction start date.

Applications must be submitted through the FLUXX grant portal. Access the FLUXX portal.

## Early Childhood Hub opens in Grand Rapids

The former Murphy Elementary School was remodeled and converted into KOOTASCA Community Action's Early Childhood Hub in Grand Rapids. The year-round facility provides care and education for 171 children ages 6 weeks to five years. There is also dedicated space for social and workforce services for families and individuals. Iron Range Resources & Rehabilitation supported the project with a



\$300,000 Development Infrastructure grant to the city of Grand Rapids to help pay for fire egress walks, a parking lot and site stormwater management. The agency also provided a \$30,000 Culture & Tourism grant to KOOTASCA Community Action to help pay for an accessible outdoor playground. Total project investment was approximately \$2 million.

The facility houses a commercial kitchen facility which will make several hundred meals and snacks fresh each day, two large indoor play areas and an outdoor community playground. KOOTASCA received two Business Energy Retrofit (BER) grants totaling \$40,000 that helped pay for new energy efficient lighting in the 2,800-square-foot gymnasium.



The opportunity to repurpose the former Murphy Elementary School was made possible when ISD 318 vacated Murphy and constructed the new East and West Elementary Schools in 2020.

In addition to child care operated by KOOTASCA and its partner Invest Early, the new hub is also home to other programs:

- Early Childhood Special Education and Early Childhood Family Education, provided by Grand Rapids Independent School District 318.
- Teenage Parent Program, provided by KOOTASCA.
- Adult Basic Education, provided by Arrowhead Economic Opportunity Agency (AEOA).
- Behavioral Health Services, provided by Children Mental Health Services.
- **Employment and Workforce Services**, provided by Northeast Minnesota Office of Jobs and Training.
- Early Childhood Internships for students enrolled in the accredited Early Childhood Education certificate program, provided by Minnesota North College-Itasca Campus.

The project relocated 14 classrooms dispersed across Grand Rapids at four separate locations and centralized the services and programs into one location at the new hub. The centralization helped achieve economic efficiencies related to staffing, human resources, bussing and other shared professional services.



"The Early Childhood Hub is a great asset to the

Grand Rapids area and to families, workers and employers in Itasca County," said Commissioner Ida Rukavina, Iron Range Resources & Rehabilitation. "We were happy to provide community development grants to support the project, which not only repurposed a vacant school building into a thriving child care center, but also co-located many important services."



The childhood hub also received a \$1.37 million KOOTASCA Targeted Community Capital Project grant from Minnesota Department of Employment & Economic Development. Other project partners included Blandin Foundation, Children's Mental Health, city of Grand Rapids, KOOTASCA

Community Action, First Children's Finance, Independent School District 318, Lake Country Power, Mardag Foundation, Minnesota Power Foundation, Northland Foundation, The Home Depot and Yanmar Compact Equipment North America.

### **November is Native American Heritage Month**

November is Native American Heritage Month. There are four tribal nations located within Iron Range Resources & Rehabilitation's service area: Bois Forte, Fond du Lac, Grand Portage and Leech Lake. All are separate, sovereign nations whose people have lived in northeastern Minnesota for centuries. Each has an independent relationship with the United States and the state of Minnesota.



The Iron Range Resources & Rehabilitation Tribal Liaison, Billie Isham works to support government-to-government

relations between the agency and the four tribal nations. Isham brings knowledge, perspective and expertise to the agency. She and Commissioner Ida Rukavina routinely consult with the Tribal Governments to identify agency grant and loan programs that may be a good fit for tribal business, community and workforce development projects.

Four recent projects supported by agency grants include:

#### Bois Forte Band of Chippewa's Vermilion Public Works Service Facility (in progress)

\$386,500 Community Infrastructure grant to assist with the infrastructure and site work for the construction of a new 13,800-square-foot public works facility. The Vermillion Public Works Facility will provide a larger area for the equipment and vehicles used in the public works and housing departments. There will be four bays for equipment and vehicles, a food shelf area, office space, a conference room and restrooms. The facility will provide food shelf services to band members residing in Vermilion and also to the surrounding communities.



# Fond du Lac Band of Lake Superior Chippewa's Water System Improvements (completed)

\$250,000 Community Infrastructure grant to assist with the improvements that allowed for the continuance of clean safe drinking water and fire protection for approximately 140 households and 550 people within a portion of the tribal territory. The project included the addition of a new 75,000-gallon

elevated water storage tower, two new wells, a water main distribution extension and a water treatment plant. The new water system was designed to reduce water contaminant levels, provide water for fire protection where none previously existed and pave the way for potential future expansion of communities that are not currently served by public utilities.

# Grand Portage Band of Lake Superior's Community Center Infrastructure Upgrade (completed)

\$146,925 Community Infrastructure grant to assist with the replacement of the outdated and inefficient heating system and indoor swimming pool liner and decking. The community center houses the Oshki Ogimaag Charter School which provides local, quality education with an emphasis on the Anishinaabe culture to grades K-6. The center is home to a tutoring program, after school programming, youth summer camps, fitness center, gymnasium and the Elderly Nutrition Program.



# Leech Lake Band of Ojibwe's Avenue of The Pines Scenic Byway S-Lake Cultural & Tourism Center (in progress)

\$243,000 Community Infrastructure grant to assist with the demolition of an existing building on a 16-acre site and to assist with construction of new community center in its place. The grant will also assist with infrastructure upgrades to the Inger RV Park and Roundhouse facility located nearby.

"Our agency works closely with each of the four Tribal Nations to discuss projects that they have prioritized within their reservations and how our grant programs can support

them," said Commissioner Ida Rukavina, Iron Range Resources & Rehabilitation. "The community infrastructure grants are helping to enhance public service buildings, essential services such as water and early child education and community gathering spaces."






# Tower Train Depot & Museum undergoes renovation, upholds historic status

The city of Tower renovated the Train Depot & Museum with a new roof and interior improvements including repair and painting of the ceiling and ticket office walls. The roof had reached the end of its useful life and was beginning to leak, causing water damage to the depot's interior. Iron Range Resources & Rehabilitation supported the project with a \$29,550 Culture & Tourism grant and \$3,000 in



Grant Writing Assistance to the city of Tower. Total project investment was \$63,440.

The city used the Grant Writing Assistance to hire professional grant writer Nancy Larson to apply for additional project funding from the Minnesota Historical Society (MHS). Larson successfully secured \$10,000 from MHS plus \$1,000 from Lake Country Power. With the multiple funding sources and grants, the city, in partnership with the Tower-Soudan Historical Society, made the needed improvements to the Tower Train Depot & Museum which is listed on the National Register of Historic Places.




"Historical society grants can be very complex, so hiring someone with Nancy's expertise increased our chances at a successful application," said Michael Schultz, city clerk and treasurer. "Also, because the depot is an official historic site, the renovation work must meet the Secretary of the Interior's Standards for the Treatment of Historic Properties, which can increase costs. The grants

she was able to secure, coupled with the Culture & Tourism grant, allowed us to complete the project to standards that honor this community treasure."

The depot was built in 1916 by the Duluth & Iron Range Railroad Company (D&IR). With service of up to three trains per day, tourists and passengers had convenient access to Tower prior to the development of the state's highway system. By providing passenger train service until 1951, the community experienced an influx of tourists wishing to visit Lake Vermilion and the many resorts, some of which were accessible only by boat. This trend spurred the resort and tourism industry on Lake Vermilion and eventually earned the community's reputation as being the gateway to the large northeastern Minnesota lake.

Located at the entrance of Tower, the train depot complex features a 1910 steam locomotive engine, passenger car and caboose. The museum tells stories of life at the turn of the century through a collection of hundreds of historic pictures and logging and mining artifacts. The museum serves as an information center and has a small gift shop. The surrounding grounds offer a picnic area,



playground, a two-room trapper's log cabin and a monument honoring United States President William McKinley who was assassinated in 1901.


#### Blackberry Township adds walking trail


The new trail increased amenities within the township and improved access to the community center, outdoor pavilion, playground and baseball field. Blackberry Township is located in Itasca County.


# City of Virginia completes grand, new entrance to Olcott Park



The city of Virginia completed construction of a new historically-inspired entrance to Olcott Park. The northern entrance (9th Street) was also widened to allow for two-way traffic and increased accessibility. Iron Range Resources & Rehabilitation supported the project with a \$20,000 Culture & Tourism grant to the city of

Virginia. Total project investment was \$200,000.

The park is home to the Olcott Park Electric Fountain and Rock Garden which the city refurbished in 2018. The fountain is officially listed in the National Register of Historic Places, placing it in the company of sites across the nation that have been declared worthy of preservation in order to protect America's historic and archaeological resources. The park is also the site of youth baseball, music in the park, picnic



pavilions, playgrounds, a disc golf course, a paved walking trail, a community greenhouse and the local historical society. Three of the region's major festivals take place each summer in Olcott: Land of the Loon, Sand Lake Shuffle and Brewfest.





#### New tax benefits available

Even if you are not required to file Minnesota income tax returns, you can still file to claim valuable Minnesota tax benefits. The Child Tax and Working Family Credits deliver tax relief to individuals whose income is below a certain level. Both credits are refundable, meaning you can receive a refund even if you do not owe tax.



#### What is the Child Tax Credit?

The new Child Tax Credit is available to Minnesotans who have children under age 18. By filing a Minnesota tax return, you may qualify for \$1,750 per child with no limit on the number of children.

#### What is the Working Family Credit?

The Working Family Credit is available to Minnesotans who earned income during the year. The maximum Working Family Credit is \$350 if your earned income is \$8,750 or more, and it can increase by:

- \$350 for no qualifying child.
- \$1,275 for one qualifying child age 18 or older.
- \$2,450 for two qualifying children age 18 or older.
- \$2,850 for three or more qualifying children age 18 or older.

Both the Child and Working Family Credits are phased out if your income is over \$35,000 for Married Filing Jointly or over \$29,500 for other filers. The credit is reduced by 12% of earned income or adjusted gross income, whichever is greater.

#### How do I claim these credits?

For tax years 2022 and earlier, claim the Working Family Credit using Schedule M1WFC, Working Family Credit. The Child Tax Credit is not available until tax year 2023. For tax years 2023 and later, claim both the Child and Working Family Tax Credits using Schedule M1CWFC, Minnesota Child and Working Family Credits, available in the next filing season.

You may also qualify for free tax return preparation. Go to <a href="www.revenue.state.mn.us">www.revenue.state.mn.us</a> and enter free tax preparation into the Search box to find free tax preparation services near you.

# Northland Foundation announces Canadian Border Counties Economic Relief Program







# Apply for a grant to prepare your community for the impacts of climate change

The effects of climate change are being felt across the state, from overwhelmed infrastructure and damaged property to excessive heat and other health threats.

Minnesota state government is partnering with local leaders to develop climateadaptation plans so that we are ready for what lies ahead. The MPCA has \$750,000 available to support climate-planning projects in communities across Minnesota.

This funding will help communities assess vulnerabilities and plan for the effects of Minnesota's changing climate in three areas:

- Improving stormwater resilience and reducing localized flood risk.
- Improving the resilience of wastewater systems.
- Reducing human health effects and adapting community services, ordinances, and public spaces.

## 2023-2024 Premium Rates

The League of Minnesota Cities Insurance Trust <u>Board of Trustees</u> evaluates loss projections every year to ensure premium rates are adequately set to respond to future claims. If estimates and members' losses are better than projected, the additional savings can be returned to members (<u>learn more about the dividend being returned for 2023</u>) or added to the Trust's fund balance for the purpose of saving money for members in other ways, such as the Trust retaining more risk.

The following provides information about premium rates going into effect for property/casualty coverages renewing on or after Nov. 15, 2023, and for workers' compensation coverages renewing on or after Jan. 1, 2024.

## Property/casualty rates

#### What does property/casualty coverage include?

Coverage is tailored specifically for Minnesota cities and related entities like housing and redevelopment authorities, joint powers organizations, and other special districts and instrumentalities. It's broader than commercial policies and includes coverage for property losses, bond, comprehensive municipal liability, auto, cyber-related claims, liquor liability, and much more.

#### How does the Trust set rates?

Rates are set at a level to generate enough premium to cover:

- Expected claim costs for the year based on actuaries' calculations.
- A contingency margin to protect the Trust and its members from the possibility that losses will be higher than expected.
- · Projected administrative expenses.

#### What are property/casualty rates for 2024?

Rates will decrease by an average of 0.75%. The following list includes specific rate changes by coverage area.

- Liability rates will decrease by an average of 6%. That consists of:
  - · A 10% decrease in employment liability rates.
  - A 15% decrease in sewer backup liability rates.
  - An 11% decrease in annual expenditure-based rates for cities.

- No rate changes for police liability, land use litigation, or annual expenditure-based rates for special purpose entities.
- Auto physical damage rates will increase 10%.
- Auto liability rates will increase 5%.
- Excess liability (optional coverage) rates will increase 3%.
- No rate changes for property or other coverages.

#### What about other variables?

Premiums will also be affected by factors such as a member's changes in expenditures, property values, payroll, experience ratings, and others. Contact the Trust's underwriting staff for questions about member-specific rates.

### Why are rates changing?

The Trust works with an actuary to help project future claim costs, which in turn drives premium rates. Here's what is happening in the property/casualty program:

- There will be no rate change for property coverage, including mobile property, because projected loss costs are stable.
- The varying decreases in liability rates will better align projected liability premiums with actual loss costs.
- Auto rates are increasing because of increased loss patterns and, like the private market, inflationary pressure.
- The 3% rate increase for excess liability is due to increased rates from the Trust's reinsurer for that line of coverage.

# Workers' compensation rates

## What is workers' compensation coverage?


Workers' compensation provides coverage for members that have employees who are injured while in the course and scope of employment.

### How does the Trust set rates?

Rates are set at a level to generate enough premium to cover:

- Expected claim costs for the year based on actuaries' calculations.
- A contingency margin to protect the Trust and its members from the possibility that losses will be higher than expected.
- Projected administrative expenses for the program.

#### What are the rate changes for 2024?



#### What about other variables?

Premiums will also be affected by factors like changes in a member's expenditures, payrolls, experience rating, and other exposure measures. Members and agents can contact their underwriter for member-specific details.

#### Why are rates changing?

The primary reason for the 15% rate decrease is because the development on members' claim experience was favorable in 2022 and 2023, both on new claims received by the Trust and on case reserves for claims occurring prior to June 30, 2022.

In recent years the Trust has communicated with members about the impact of post-traumatic stress disorder (PTSD) claims for public safety on the Trust's workers' compensation program. Premium rate increases have been necessary because these claims became a significant portion of the Trust's costs claim patterns; however, both PTSD and non-PTSD claims have changed the course of future claim projections, at least for 2024.

Whether and how PTSD, other types of claims, or legislative changes will affect workers' compensation rates in the future is impossible to know with certainty. There's inherent unpredictability in managing risk and knowing the cost of future claims. The Trust evaluates claim patterns through data analyses and actuarial projections to set premium rates as responsibly as possible. The Trust also has programs, services, and staff available to help members control all types of claims - from back injuries to land use and everything in between.

## Are there any other changes we should be aware of?

Nonsmoker credit: There is a discount in the workers' compensation rate for firefighters and police officers if members can assert 90% of their departments are nonsmokers. The rate credit will decrease from 10% to 5% because a recent evaluation shows members with "nonsmoking" departments have worse claim experience than "smoking" departments. Because of this, the nonsmoking credit will be phased out and discontinued on Jan. 1, 2025.

Experience rating: A few minor, primarily technical changes will be made to the Trust's experience rating formula for 2024 to align with revised industry standards.
